RESOLUTION 14129. SACRAMENTO CELLULAR TELEPHONE COMPANY (CIS ID NO. U-3013-C). EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A NEW CELL SITE IN THE SACRAMENTO METROPOLITAN STATISTICAL AREA.

SUMMARY

Sacramento Cellular Telephone Company (SACTO), by Advice Letter No. 25, filed on June 26, 1990, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a new cellular radiotelephone cell site to its existing cellular system serving the Sacramento Metropolitan Statistical Area. This Resolution authorizes the construction of the new cell site, known as the Pocket site, located at 1155 South River Road, West Sacramento, CA. No protests to this Advice Letter have been filed.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in its application for a certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption. DISCUSSION

Advice Letter No. 25 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

SACTO has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the City of West Sacramento, the Federal Aviation Administration, and the Federal Communications Commission.

The proposed construction will be located at 1155 South River Road, West Sacramento, CA and is known as the Pocket site. It will consist of one 150-foot steel lattice self-supporting tower and one 11' x 28' x 12' concrete and steel modular building covering approximately 330 square feet. The poposed site is located in an agricultural area and is accessible by an existing dirt road.

The Pocket site will become part of SACTO's cellular system serving the Sacramento Metropolitan Statistical Area.

Public notice that Sacramento Cellular Telephone Company filed Advice Letter No. 25 requesting authority to construct the Pocket site appeared in the California Public Utilities Commission's June 29, 1990 Daily Calendar. In addition, copies of SACTO's Advice Letter No. 25 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been filed on SACTO's Advice Letter No. 25.

FINDINGS

- On June 26, 1990, Sacramento Cellular Telephone Company filed Advice Letter No. 25 requesting Executive authorization to construct the Pocket cell site located at 1155 South River Road, West Sacramento, CA.
- 2. The Pocket site represents an additional cellular radiotelephone facility not described in D. 87-10-037, granting SACTO a certificate of public convenience and necessity.

- 3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
- 4. Advice Letter No. 25 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A SACTO officer signed a declaration which states that SACTO has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 25.
- 6. Advice Letter No. 25 lists the following entities which have jurisdiction over the proposed construction of the Pocket cell site: the City of West Sacramento, the Federal Aviation Administration, and the Federal Communications Commission.
- 7. Advice Letter No. 25 states that the City of West Sacramento, the Federal Aviation Administration, and the Federal Communications Commission comprise all governmental entities that have jurisdiction over the proposed construction of the Pocket cell site.

THEREFORE, IT IS ORDERED that:

- (1) Sacramento Cellular Telephone Company's request for authority to construct the Pocket cell site is granted.
- (2) The effective date of this resolution is July 26, 1990.
