Commission. Its FAA permit is outstanding, but it has furnished documented independent review that the proposed construction is in compliance with FAA requirements.

The proposed construction will be located on an existing communications development at 390 Butcher Road, Vacaville, CA and is known as the NM13 Prison Enhancer site. It will consist of one 40-foot wooden pole with two cellular antennas and a control box

The NM13 Prison Enhancer site will become part of NAPA CELLULAR's cellular system serving the Napa Cellular Geographic Service Area.

Public notice that NAPA CELLULAR TELEPHONE COMPANY filed Advice Letter No. 22 requesting authority to construct the NM13 Prison Enhancer site appeared in the California Public Utilities Commission's October 9, 1990 Daily Calendar. In addition, copies of NAPA CELLULAR's Advice Letter No. 22 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been filed on NAPA CELLULAR's Advice Letter No. 22.

FINDINGS

1. On October 3, 1990, NAPA CELLULAR TELEPHONE COMPANY filed Advice Letter No. 22 requesting Executive authorization to construct the NM13 Prison Enhancer cell site located at 390 Butcher Road, Vacaville, CA.
2. The NM13 Prison Enhancer site represents an additional cellular radiotelephone facility not described in Decision 88-02-034, granting NAPA CELLULAR a certificate of public convenience and necessity.
3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
4. Advice Letter No. 22 conforms to the requirements of Decision 90-03-080 and G.O. 159.
5. A NAPA CELLULAR officer signed a declaration which states that NAPA CELLULAR has received or will receive all necessary permits or approvals from the governmental


entities listed in Advice Letter No. 22. Local review and approval by the City of Vacaville has been obtained.

6. Advice Letter No. 22 lists the following entities which have jurisdiction over the proposed construction of the NM13 Prison Enhancer cell site: City of Vacaville, Federal Aviation Administration, and the Federal Communications Commission.
7. Advice Letter No. 22 states that City of Vacaville, Federal Aviation Administration, and the Federal Communications Commission comprise all governmental entities that have jurisdiction over the proposed construction of the NM13 Prison Enhancer cell site.

THEREFORE, IT IS ORDERED that:

- (1) NAPA CELLULAR TELEPHONE COMPANY's request for authority to construct the NM13 Prison Enhancer cell site is granted.
- (2) The effective date of this resolution is November 11, 1990.
