# RESOLUTION

RESOLUTION T-14217. LOS ANGELES SMSA LIMITED PARTNERSHIP. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF NEW CELL SITES IN THE LOS ANGELES METROPOLITAN AREA.

BY ADVICE LETTER NO. 81, FILED ON OCTOBER 5, 1990.

#### **SUMMARY**

Los Angeles SMSA Limited Partnership (LASLP), by Advice Letter No. 81, filed on October 5, 1990, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add new cellular radiotelephone cell sites to its existing cellular system serving the Los Angeles metropolitan area. This Resolution authorizes the construction of 14 new cell sites:

No protests to this Advice Letter have been filed.

## **BACKGROUND**

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in its application for a certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

### DISCUSSION

Advice Letter No. 81 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

LASLP has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): Federal Aviation Administration, Federal Communications Commission, City of Torrance Department of Building and Safety, County of Riverside Department of Building and Safety, City of Huntington Park Building Department, City of Huntington Beach Building Department, City of Long Beach Building Department, City of Fontana Building Department, City of Monterey Park Building Department, City of Costa Mesa Building Department, City of Anaheim Building Department, City of Los Alamitos Building and Safety Division and the City of Laguna Hills Building Department.

A description of the proposed construction is listed below by cell site name and location.

City (Cell Site Name) - Address
Torrance (Lomita) - 33 48' 41"N 118 19'49"W
Construction consists of a 20x20-foot cellular communication facility on the first floor of an existing building. The facility will house electrical radio and power equipment. A 43-foot monopole will be placed adjacent to the building.

Torrance (Moneta) - 18411 Crenshaw Boulevard Construction consists of a 600 square foot cellular communication facility on the garden level basement floor of an existing building. The facility will house electrical radio and power equipment. Face mounted antennas will be attached to the north, east and west surfaces of the existing penthouse and a 2-foot microwave dish facing east will be mounted on the roof.

Corona (Temescal) - 24130 Warm Springs Road Construction consists of a 28x12-foot communications facility to house electrical radio and power equipment. A 25-foot utility pole will be placed adjacent to the facility.

Huntington Park (Maywood) - 6025 Maywood Ave. #17 Construction consists of a 482 square foot facility in an existing single story building. The facility will house electrical radio and power equipment. The project also involves placement of a 60-foot monopole antenna.

Huntington Beach (Westmont II) - 16052 Beach Boulevard Construction consists of a 569 square foot facility on the second floor of an existing building. The facility will house electrical radio and power equipment. Antennas will be facemounted to the parapet of the building.

Huntington Beach (Cutty Sark) - 9901 Adams Avenue Construction consist of a 500 square foot facility on the first floor of an existing building. The facility will house electrical radio and power equipment. Antennas will be facemounted to the parapet of the building.

Long Beach (Bellflower) - 2700 Bellflower Boulevard Construction consist of a 630 square foot facility on the third floor of an existing building. The facility will house electrical radio and power equipment. Antennas will be facemounted to the parapet of the building.

Fontana (Shurgard) - 17173 Valley Construction consists of a 600 square foot facility in an existing building. The facility will house electrical radio and power equipment. The project also involves placement of a 60-foot monopole antenna.

Monterey Park (Montebello) - 215 W. Pomona Boulevard Construction consists of a 400 square foot facility on the second floor of an existing building. The facility will house electrical radio and power equipment. A five-foot cellular antenna will be attached to the roof of the building.

Costa Mesa (Harbor Rest) - 1503 South Coast Drive #313 Construction consist of a 915 square foot facility on the third floor of an existing building. The facility will house electrical radio and power equipment. Antennas will be facemounted to the parapet of the building.

Anaheim (Olive) - 970 N. Tustin Avenue Construction consist of a 900 square foot facility on the third floor of an existing building. The facility will house electrical radio and power equipment. Antennas will be facemounted to the parapet of the building.

Huntington Beach (Seal Beach II) - 15922 Pacific Coast Drive Construction consist of a 550 square foot facility on the second floor of an existing building. The facility will house

electrical radio and power equipment. Antennas will be facemounted to the parapet of the building.

Los Alamitos - 4342 Katella Avenue Construction consist of a 560 square foot facility on the second floor of an existing building. The facility will house electrical radio and power equipment. Antennas will be facemounted to the parapet of the building.

Laguna Hills (Lake Forest) - 2304 Avenida De La Carlota Construction consist of a 560 square foot facility on the second floor of an existing building. The facility will house electrical radio and power equipment. Antennas will be facemounted to the parapet of the building.

The 14 new cell sites (Torrance-Lomita, Torrance-Moneta, Corona-Temescal, Huntington Park-Maywood, Huntington Beach-Westmont II, Huntington Beach-Cutty Sark, Long Beach-Bellflower, Fontana-Shurgard, Monterey Park-Montebello, Costa Mesa-Harbor Rest, Anaheim-Olive, Huntington Beach-Seal Beach II, Los Alamitos, Laguna Hills-Lake Forest) will become part of LASLP's cellular system serving the Los Angeles metropolitan area.

Public notice that Los Angeles SMSA Limited Partnership filed Advice Letter No. 81 requesting authority to construct the 14 new cell sites (Torrance-Lomita, Torrance-Moneta, Corona-Temescal, Huntington Park-Maywood, Huntington Beach-Westmont II, Huntington Beach-Cutty Sark, Long Beach-Bellflower, Fontana-Shurgard, Monterey Park-Montebello, Costa Mesa-Harbor Rest, Anaheim-Olive, Huntington Beach-Seal Beach II, Los Alamitos, Laguna Hills-Lake Forest) appeared in the California Public Utilities Commission's October, 12, 1990 Daily Calendar. In addition, copies of LASLP's Advice Letter No. 81 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

#### PROTESTS

No protests have been filed on LASLP's Advice Letter No. 81.

#### FINDINGS

1. On October 5, 1990, Los Angeles SMSA Limited Partnership filed Advice Letter No. 81 requesting Executive authorization to construct 14 new cell sites as listed below.

The 14 new cell sites (Torrance-Lomita, Torrance-Moneta, Corona-Temescal, Huntington Park-Maywood, Huntington Beach-Westmont II, Huntington Beach-Cutty Sark, Long Beach-Bellflower, Fontana-Shurgard, Konterey Park-Montebello, Costa Mesa-Harbor Rest, Anaheim-Olive, Huntington Beach-Seal Beach II, Los Alamitos, Laguna Hills-Lake Forest) represent additional cellular radiotelephone facilities not described in D.87-04-014, granting LASLP a certificate of public convenience and necessity.
- 3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
- 4. Advice Letter No. 81 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A LASLP officer signed a declaration which states that LASLP has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 81.
- 6. Advice Letter No. 81 lists the following entities which have jurisdiction over the proposed construction of the 14 new cell sites (Torrance-Lomita, Torrance-Moneta, Corona-Temescal, Huntington Park-Maywood, Huntington Beach-Westmont II, Huntington Beach-Cutty Sark, Long Beach-Bellflower, Fontana-Shurgard, Monterey Park-Montebello, Costa Mesa-Harbor Rest, Anaheim-Olive, Huntington Beach-

Seal Beach II, Los Alamitos, Laguna Hills-Lake Forest): Federal Aviation Administration, Federal Communications Commission, City of Torrance Department of Building and Safety, County of Riverside Department of Building and Safety, City of Huntington Park Building Department, City of Huntington Beach Building Department, City of Long Beach Building Department, City of Fontana Building Department, City of Monterey Park Building Department, City of Costa Kesa Building Department, City of Anaheim Building Department, City of Los Alamitos Building and Safety Division and the City of Laguna Hills Building Department.

# THEREFORE, IT IS ORDERED that:

- (1) Los Angeles SMSA Limited Partnership's request for authority to construct the 14 new cell sites (Torrance-Lomita, Torrance-Moneta, Corona-Temescal, Huntington Park-Maywood, Huntington Beach-Westmont II, Huntington Beach-Cutty Sark, Long Beach-Bellflower, Fontana-Shurgard, Monterey Park-Montebello, Costa Mesa-Harbor Rest, Anaheim-Olive, Huntington Beach-Seal Beach II, Los Alamitos, Laguna Hills-Lake Forest) is granted.
- (2) The effective date of this resolution is November 5, 1990.
