R E S O L U T I O N

RESOLUTION T-14293. STOCKTON CELLULAR TELEPHONE COMPANY,
EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A NEW CELL
SITE IN THE STOCKTON METROPOLITAN STATISTICAL AREA.

BY ADVICE LETTER NO. 32, FILED ON December 17, 1990.

SUMMARY

Stockton Cellular Telephone Company (SKTC), by Advice Letter No. 32, filed on December 17, 1990, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add twelve cellular antennas to its existing Manteca cell site in the Stockton Metropolitan Statistical Area. This Resolution authorizes the addition of these twelve antennas to the Manteca cell site, located at 20450 S. Murphy Road, Ripton, California. No protests to this Advice Letter have been filed.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in its application for a certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 32 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities. Authority to construct the original system, a certificate of public convenience and necessity, was granted to SKTC by Decision 87-06-019.

The new Manteca site represents modification of an existing cellular radiotelephone facility not described in D.87-06-019, granting SKTC a certificate of public convenience and necessity.

SKTC has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): County of San Joaquin, the Federal Aviation Administration, and the Federal Communications Commission.

The proposed construction will be located at 20450 S. Murphy Road, Ripton, California. Twelve antennas will be added to the Manteca cell site. There is an existing 200-foot lattice tower and existing 12-foot x 28-foot x 10-foot concrete and steel modular building at the site. The site is zoned Agricultural (AG-40) and is accessible by an existing dirt road. The Manteca site is part of SKTC's cellular system serving the Stockton Metropolitan Statistical Area.

Public notice that Stockton Cellular Telephone Company filed Advice Letter No. 32 requesting authority to add twelve antennas to the existing Manteca cell site appeared in the California Public Utilities Commission's December 19, 1990. In addition, copies of SKTC's Advice Letter No. 32 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been filed on SKTC's Advice Letter No. 32.

FINDINGS

1. On December 17, 1990, Stockton Cellular Telephone Company filed Advice Letter No. 32 requesting Executive authorization to add twelve antennas to the Manteca cell site located at 20450 S. Murphy Road, Ripton, California.
2. The addition of twelve antennas to the Manteca cell site represents a modification of an existing cellular radiotelephone facility not described in Decision 87-06-019, granting SKTC a certificate of public convenience and necessity.
3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.



4. Advice Letter No. 32 conforms to the requirements of Decision 90-03-080 and G.O. 159.
5. A SKTC officer signed a declaration which states that SKTC has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 32.
6. Advice Letter No. 32 lists the following entities which have jurisdiction over the proposed construction of the Woodbridge cell site: County of San Joaquin, the Federal Aviation Administration, and the Federal Communications Commission.

THEREFORE, IT IS ORDERED that:

- (1) Stockton Cellular Telephone Company's request for authority to construct the Woodbridge cell site is granted.
- (2) The effective date of this resolution is January 17, 1991.
