RESOLUTION

RESOLUTION T-14322. LOS ÀNGELES CELLULAR TELEPHONE COMPANY. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A NEW CELL SITE IN THE LOS Angeles Cellular Geographic Service Area.

BY ADVICE LETTER NO. 85, FILED ON January 16, 1991.

<u>SUMMARY</u>

LOS ANGELES CELLULAR TELEPHONE COMPANY (LACTC), by Advice Letter No. 85, filed on January 16, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a new cellular radiotelephone cell site to its existing cellular system serving the Los Angeles Cellular Geographic Service Area. This Resolution authorizes the construction of the new cell site, known as Los Angeles Cellular Site No. 101, located at 45009 Afton Canyon Road, Afton, California, 116 degrees 22' 40" W, 35 degrees 04' 20" N. No protests to this Advice Letter have been received.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting a certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 85 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

Los Angeles Cellular Site No. 101 représents an additional cellular radiotelephone facility not describéd in Decision 84-06-110, granting LACTC a certificate of public convenience and necessity.

LACTC has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the County of San Bernardino, the Federal Aviation Administration, and the Federal Communications Commission.

Thé proposéd construction will bé locatéd at 45009 Afton Canyon Road, Afton, California, 116 degréés 22' 40" W, 35 degrées 04' 20" N and is known as Los Angélés Céllular Sité No. 101. It will bé à temporary installation and consist of three 20 foot wood poles and one temporary trailér.

Los Angélés Cellular Sité No. 101 will bécomé part óf LACTC's cellular system sérving the Los Angéles Cellular Géographic Sérvicé Aréa.

NOTICE

Public notice that LOS ANGELES CELLULAR TELEPHONE COMPANY filed Advice Letter No. 85 requesting authority to construct Los Angélès Cellular Sité No. 101 appeared in the California Public Utilities Commission's January 18, 1991 Daily Calendar. In addition, copiés of LACTC's Advice Letter No. 85 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been received to LACTC's Advice Letter No. 85.

FINDINGS

- On January 16, 1991, LOS ANGELES CELLULAR TELEPHONE COMPANY filed Advice Letter No. 85 requesting Executive authorization to construct Los Angeles Cellular Site No. 101, located at 45009 Afton Canyon Road, Afton, California, 116 degrees 22' 40" W, 35 degrees 04' 20" N.
- Los Angeles Cellular Site No. 101 represents an additional cellular radiotelephone facility not described in Decision 84-06-110, granting LACTC a certificate of public convenience and necessity.
- 3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
