R E S O L U T I O N

RESOLUTION T-14358. SACRAMENTO CELLULAR TELEPHONE COMPANY. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A NEW CELL SITE IN THE SACRAMENTO STANDARD METROPOLITAN STATISTICAL AREA

BY ADVICE LETTER NO. 46, FILED ON FEBRUARY 27, 1991.

SUMMARY

SACRAMENTO CELLULAR TELEPHONE COMPANY (SCTC), by Advice Letter No. 46, filed on February 27, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a new cellular radiotelephone cell site to its existing cellular system serving the Sacramento Metropolitan Statistical Area. This Resolution authorizes the construction of the new cell site, known as the Frontier Radio site, located at 4401 Auburn Blvd., North Highlands, CA. No protests to this Advice Letter have been received.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 46 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The Frontier Radio site represents an additional cellular radiotelephone facility not described in D.87-10-037, granting SCTC a certificate of public convenience and necessity.

SCTC has obtained permits or approvals from the following governmental entities and asserts that these entities comprise

all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission); County of Sacramento, the Federal Aviation Administration, and the Federal Communications Commission.

The proposed construction will be located at 4401 Auburn Blvd., North Highlands, CA and is known as the Frontier Radio site. It will consist of twelve cellular antennas to be mounted at the 85 foot level on an existing 105' monopole and a powerplant and radio equipment housed in a 12 x 28 x 10 foot concrete and steel modular building

The Frontier Radio site will become part of SCTC's cellular system serving the Sacramento Metropolitan Statistical Area.

#### NOTICE

Public notice that SACRAMENTO CELLULAR TELEPHONE COMPANY filed Advice Letter No. 46 requesting authority to construct the Frontier Radio site appeared in the California Public Utilities Commission's March 1, 1991 Daily Calendar. In addition, copies of SCTC's Advice Letter No. 46 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

#### PROTESTS

No protests have been received to SCTC's Advice Letter No. 46.

#### FINDINGS

1. On February 27, 1991, SACRAMENTO CELLULAR TELEPHONE COMPANY filed Advice Letter No. 46 requesting Executive authorization to construct the Frontier Radio cell site located at 4401 Auburn Blvd., North Highlands, CA.
2. The Frontier Radio site represents an additional cellular radiotelephone facility not described in 87-10-037, granting SCTC a certificate of public convenience and necessity.
3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
4. Advice Letter No. 46 conforms to the requirements of Decision 90-03-080 and G.O. 159.



5. An SCTC officer signed a declaration which states that SCTC has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 46.
6. Advice Letter No. 46 lists the following entities which have jurisdiction over the proposed construction of the Frontier Radio cell site: County of Sacramento, the Federal Aviation Administration, and the Federal Communications Commission.
7. No protest to Advice Letter No. 46 have been received.

THEREFORE, IT IS ORDERED that:

- (1) SACRAMENTO CELLULAR TELEPHONE COMPANY's Advice Letter No. 46 is hereby approved.
- (2) The effective date of this resolution is March 27, 1991.
