## RESQLUTION

RESOLUTION T-14376. BAY AREA CELLULAR TELEPHONE COMPANY. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A CELL SITE IN THE SAN FRANCISCO/SAN JOSE CELLULAR GEOGRAPHIC SERVICE AREA.

Bay Area Cellular Telephone Company (BACTC), by Advice Letter No. 81, filed on February 27, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a new cellular radiotelephone cell site to its existing cellular system serving the San Francisco/San Jose Cellular Geographic Service Area. This Resolution authorizes the construction of the cell site, known as the Highway 13 site, located at 1900 Mountain Blvd., Oakland, CA. No protests to this Advice Letter have been received.

## BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

## DISCUSSION

Advice Letter No. 81 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The Highway 13 site represents an additional cellular radiotelephone facility not described in D.86-05-010, granting BACTC a certificate of public convenience and necessity.

BACTC has obtained permits or approvals from the following governmental entities and asserts that these entities comprise

all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the City of Oakland, and the Federal Communications Commission.

The proposed construction will be located at 1900 Mountain Blvd., Oakland, CA and is known as the Highway 13 site. It will consist of a 300-square-foot equipment shelter constructed within space on the first floor of an existing two-story commercial/residential building. In addition, four cellular antennas will be mounted on the south and north sides of the roof of the building and will extend approximately two feet above the rooftop. Power will be supplied from an existing multi-meter panel located in an electrical closet on the first floor of the building. Power will be fed to the shelter through approximately 220 feet of exposed conduit on the ceiling of the ground level garage.

The Highway 13 site will become part of BACTC's cellular system serving the San Francisco/San José Cellular Geographic Service Area.

- The Highway 13 site represents an additional cellular radiotelephone facility not described in D.86-05-010, granting BACTC a certificate of public convenience and necessity.

- 3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
- Advicé Letter No. 81 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A BACTC officer signed a declaration which states that BACTC has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 81.
- Advice Letter No. 81 lists the following entities which have jurisdiction over the proposed construction of the Highway 13 cell site: the City of Oakland, and the Federal Communications Commission.
- 7. No protests to Advice Letter No. 81 have been received.

### THEREFORE, IT IS ORDERED that:

- Bay Area Cellular Telephone Company's Advice Letter No. 81 is hereby approved.
