RESQLUTION

RESOLUTION T-14434. PACTEL CELLULAR. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF THREE CELL SITES IN THE SAN DIEGO METROPOLITAN AREA.

BY ADVICE LETTER NO. 57, FILED ON APRIL 18, 1991.

SUMMARY

PACTEL CELLULAR (PacTel), by Advice Letter No. 57, filed on April 18, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add three cellular radiotelephone cell sites to its existing cellular system serving the San Diego Metropolitan Area. This Resolution authorizes the construction of three cell sites, known as the Mission Valley, Ramona, and San Marcos, located at 591 Camino de la Reina, San Diego, CA, 18303 Spring Wagon Road, Ramona, CA, and 1219 Rancho Luiseno Road, San Marcos, CA, respectively. No protests to this Advice Letter have been filed.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 57 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The three sites, Mission Valley, Ramona, and San Marcos, represent additional cellular radiotelephone facilities not described in D.85-04-023, granting PacTel a certificate of public convenience and necessity.

PacTél has obtained pérmits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the City of San Diego, the County of San Diego, the Federal Aviation Administration, and the Federal Communications Commission.

The proposed construction for the three cell sites will be located at 591 Camino de la Reina, San Diego, CA, 18303 Spring Wagon Road, Ramona, CA, and 1219 Rancho Luiseno Road, San Marcos, CA and are known as the Mission Valley, Ramona, and San Marcos sites respectively. The Mission site will consist of adding 15 directional panel antennas to 6 existing 8-foot poles. The Ramona site will consist of mounting antennas to a 80-foot monopole and a 288 square foot equipment structure. Finally, the San Marcos site will consist of mounting antennas on a 100foot tower and a 288 square foot equipment shelter.

The three cell sites, Mission Valley, Ramona, and San Marcos, will become part of PacTel's cellular system serving the San Diego Métropolitan Area.

NOTICE

Public notice that PACTEL CELLULAR filed Advice Letter No. 57 requesting authority to construct three cell sites, Mission Valley, Ramona, and San Marcos appeared in the California Public Utilities Commission's April 20, 1991 Daily Calendar. In addition, copies of PacTel's Advice Letter No. 57 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been filed on PacTel's Advice Letter No. 57.

FINDINGS

 On April 18, 1991, PACTEL CELLULAR filed Advice Letter No. 57 requesting Executive authorization to construct three cell sites, Mission Valley, Ramona, and San Marcos, located at 591 Camino de la Reina, San Diego, CA, 18303 Spring Wagon Road, Ramona, CA, and 1219 Rancho Luiseno Road, San Marcos, CA respectively. Resolution T-14434 Effective Nay 20, 1991) PACTEL/A.L. No.57/JGB

- The Mission Valley, Ramona, and San Marcos sites represent additional cellular radiotelephone facilities not described in D.85-04-023, granting PacTel a certificate of public convenience and necessity.
- 3. Decisión 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
- 4. Advice Letter No. 57 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A PacTel officer signed a declaration which states that PacTel has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 57.
- 6. Advice Letter No. 57 lists the following entities which have jurisdiction over the proposed construction of the Mission Valley, Ramona, and San Marcos cell sites: the City of San Diego, the County of San Diego, the Federal Aviation Administration, and the Federal Communications Commission.
- 7. No protests to Advice Letter No. 57 have been received.

THEREFORE, IT IS ORDERED that:

- PACTEL CELLULAR's request for authority to construct three cell sites, Mission Valley, Ramona, and San Marcos, is granted.
- (2) The effective date of this resolution is May 20, 1991.
