RESOLUTION T-14437. STOCKTON CELLULAR TELEPHONE COMPANY. EXECUTIVE ORDER AUTHORIZING THE MODIFICATION OF AN EXISTING CELL SITE IN THE STOCKTON METROPOLITAN AREA.

BY ADVICE LETTER NO. 41, FILED ON APRIL 23, 1991.

SUMMARY

STOCKTON CELLULAR TELEPHONE COMPANY (SCTC), by Advice Letter No. 41, filed on April 23, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to modify an existing cellular radiotelephone cell site serving the Stockton Metropolitan Area. This Resolution authorizes the remodeling of the cell site, known as the Stockton Mobile Telephone Switching Office site, located at 9590 Blanco Road, Stockton, CA. No protests to this Advice Letter have been received.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 41 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to modify existing cellular facilities.

The Stockton Mobile Telephone Switching Office site represents modification of an existing cellular radiotelephone facility not described in D.87-11-061, granting SCTC a certificate of public convenience and necessity.

SCTC has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed modification (with the exception of the California Public Utilities Commission): the County of San Joaquin, the Federal Aviation Administration, and the Federal Communications Commission.

The proposed modification is to an existing cell site located at 9590 Blanco Road, Stockton, CA and is known as the Stockton Mobile Telephone Switching Office site. The modification consists of remodeling 4,000 square feet of the existing 12,000 square feet building to house equipment.

The Stockton Mobile Telephone Switching Office site is currently and will remain part of SCTC's cellular system serving the Stockton Metropolitan Area.

#### NOTICE

Public notice that STOCKTON CELLULAR TELEPHONE COMPANY filed Advice Letter No. 41 requesting authority to modify the Stockton Mobile Telephone Switching Office site appeared in the California Public Utilities Commission's April 26, 1991 Daily Calendar. In addition, copies of SCTC's Advice Letter No. 41 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

#### PROTESTS

No protests have been received to SCTC's Advice Letter No. 41.

#### FINDINGS

1. On April 23, 1991, STOCKTON CELLULAR TELEPHONE COMPANY filed Advice Letter No. 41 requesting Executive authorization to modify the Stockton Mobile Telephone Switching Office cell site located at 9590 Blanco Road, Stockton, CA.

2. The Stockton Mobile Telephone Switching Office site represents an existing cellular radiotelephone facility not described in 87-11-061, granting SCTC a certificate of public convenience and necessity.
3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
4. Advice Letter No. 41 conforms to the requirements of Decision 90-03-080 and G.O. 159.
5. A SCTC officer signed a declaration which states that SCTC has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 41.
6. Advice Letter No. 41 lists the following entities which have jurisdiction over the proposed modification of the Stockton Mobile Telephone Switching Office cell site: the County of San Joaquin, the Federal Aviation Administration, and the Federal Communications Commission.
7. No protests to Advice Letter No. 41 have been received.

THEREFORE, IT IS ORDERED that:

- (1) STOCKTON CELLULAR TELEPHONE COMPANY's Advice Letter No. 41 is hereby approved.

RESOLUTION T-14437. LOS ANGELES CELLULAR TELEPHONE COMPANY. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A CELL SITE IN THE LOS ANGELES CELLULAR GEOGRAPHIC SERVICE AREA.

SUMMARY

LOS ANGELES CELLULAR TELEPHONE COMPANY (LACTC), by Advice Letter No. 126, filed on May 10, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a new cellular radiotelephone cell site to its existing cellular system serving the Los Angeles Cellular geographic Service Area. This Resolution authorizes the construction of the cell site, known as Los Angeles Cellular Site No. 196, located at 7928 Melrose Avenue, Los Angeles, CA. No protests to this Advice Letter have been received.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 126 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

Los Angeles Cellular Site No. 196 represents an additional cellular radiotelephone facility not described in D.84-06-010, granting LACTC a certificate of public convenience and necessity.

LACTC has obtained permits or approvals from the following governmental entity and asserts that this entity is the sole governmental entity that has jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): The City of Los Angeles.

The proposed construction will be located at 7928 Melrose Avenue, Los Angeles, CA and is known as Los Angeles Cellular Site No. 196. Three antenna units, each with 3 sets of 4 antel type antennas (12 panel antennas) will be mounted on the roof of an existing commercial building and will extend a maximum of 3 feet above the roof. Equipment including radio receivers, transmitter and associated electrical equipment and direct, metered power supply will be housed in the first floor of the two-story portion of the same, existing commercial building. Antennas will be painted to match the roof color.

Los Angeles Cellular Site No. 196 will become part of LACTC's cellular system serving the Los Angeles Cellular geographic Service Area.

Public notice that LOS ANGELES CELLULAR TELEPHONE COMPANY filed Advice Letter No. 126 requesting authority to construct Los Angeles Cellular Site No. 196 appeared in the California Public Utilities Commission's May 17, 1991 Daily Calendar. In addition, copies of LACTC's Advice Letter No. 126 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

#### PROTESTS

No protests have been received to LACTC's Advice Letter No. 126.

#### FINDINGS

1. On May 10, 1991, LOS ANGELES CELLULAR TELEPHONE COMPANY filed Advice Letter No. 126 requesting Executive authorization to construct Los Angeles Cellular Site No. 196 cell located at 7928 Melrose Avenue, Los Angeles, CA.
2. Los Angeles Cellular Site No. 196 represents an additional cellular radiotelephone facility not described in D.84-06-010, granting LACTC a certificate of public convenience and necessity.
3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone



- facilities not described in a utility's certificate of public convenience and necessity.
4. Advice Letter No. 126 conforms to the requirements of Decision 90-03-080 and G.O. 159.

  6. Advice Letter No. 126 lists the following entity which has jurisdiction over the proposed construction of Los Angeles Cellular Site No. 196: The City of Los Angeles.
