RESQLUTION

RESOLUTION T-14495. LOS ANGELES SMSA LIMITED PARTNERSHIP. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF FOUR CELL SITES IN THE LOS ANGELES METROPOLITAN AREA.

BY ADVICE LETTER NO. 100, FILED ON MAY 8, 1991.

SUMMARY

LOS ANGELES SMSA LIMITED PARTNERSHIP (LASLP), by Advice Letter No. 100, filed on May 8, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add four cellular radiotelephone cell sites to its existing cellular system serving the Los Angeles Metropolitan Area. This Resolution authorizes the construction of four cell sites, known as the Riverside - La Sierra, Los Angeles - Valley College, Orange - Katella, and San Juan Capistrano sites, located at 3715 La Sierra Avenue, Riverside, CA, 6260 Laurel Canyon Boulevard, Los Angeles, CA, 1855 West Katella Avenue, Orange, CA, and 27174 Ortega Highway, San Juan Capistrano, respectively. No protests to this Advice Letter have been filed.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 100 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities. Resolution T-14495 Effective June 10, 1991 LASLP/A.L. No. 100/JGB

The four sites, Riverside - La Sierra, Los Angeles - Valley College, Orange - Katella, and San Juan Capistrano, represent additional cellular radiotelephone facilities not described in D.84-04-014, granting LASLP a certificate of public convenience, and necessity.

LASLP has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission); the Cities of Riverside, Los Angeles, Orange, and San Juan Capistrano, the Federal Aviation Administration, and the Federal Communications Commission.

The proposed construction for the four cell sites will be located at 3715 La Sierra Avenué, Riverside, CA, 6260 Laurel Canyon Boulévard, Los Angelés, CA, 1855 West Katella Avenue, Orange, CA, and 27174 Ortega Highway, San Juan Capistrano. Theses sites are known as the Riverside - La Sierra, Los Angeles - Valley College, Orange - Katella, and San Juan Capistrano sites respectively. The Riverside - La Sierra site will consist of microwave and cellular antennas on a 90-foot monopole and an equipment shelter on the second floor of an existing building. The Los Angeles - Valley College site will consist of microwave and cellular antennas attached to a penthouse and an equipment shelter on the second floor of an existing building. The Orange - Katella site will consist of antennas attached to the parapet The Orange of an existing building and an equipment shelter on the third floor of an existing building. Finally, the San Juan Capistrano site will consist of antennas attached to the parapet of an existing building and an equipment shelter in the basement of an existing building.

Thé four cell sites, Riverside - La Sierra, Los Angelés - Valley Collège, Orange - Katella, and San Juán Cápistrano, will become part of LASLP's cellular systèm serving the Los Angeles Metropolitan Area.

Public notice that LOS ANGELES SMSA LIMITED PARTNERSHIP filed Advice Letter No. 100 requesting authority to construct four cell sites, Riverside - La Sierra, Los Angeles - Valley College, Orange - Katella, and San Juan Capistrano appeared in the California Public Utilities Commission's May 10, 1991 Daily Calendar. In addition, copies of LASLP's Advice Letter No. 100 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification. FINDINGS

- On May 8, 1991, LOS ANGELES SMSA LIMITED PARTNERSHIP filed Advice Letter No. 100 requesting Executive authorization to construct four cell sites, Riverside - La Sierra, Los Angeles - Valley College, Orange - Katella, and San Juan Capistrano, located at 3715 La Sierra Avenue, Riverside, CA, 6260 Laurel Canyon Boulevard, Los Angeles, CA, 1855 West Katella Avenue, Orange, CA, and 27174 Ortega Highway, San Juan Capistrano respectively.
- The Riverside La Sierra, Los Angeles Valley College, Orangé - Katella, and San Juan Capistrano sites réprésent additional cellular radiotelephone facilities not déscribed in D.84-04-014, granting LASLP à certificaté of public convenience and necessity.
- 3. Decisión 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not describéd in a utility's certificate of public convenience and necessity.
- 4. Advice Letter No. 100 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A LASLP officer signed a declaration which states that LASLP has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 100.
- 6. Advice Letter No. 100 lists the following entitles which have jurisdiction over the proposed construction of the Riverside - La Sierra, Los Angeles - Valley Collége, Orange - Katella, and San Juan Capistrano cell sites: the Cities of Riverside, Los Angeles, Orange, and San Juan Capistrano, the Federal Aviation Administration, and the Federal Communications Commission.
- 7. No protests to Advice Letter No. 100 have been received.
