RESOLUTION T-14501. LOS ANGELES SMSA LIMITED. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF FIVE CELL SITES IN THE LOS ANGELES METROPOLITAN AREA.

SUMMARY

LOS ANGELES SMSA LIMITED (LASLP), by Advice Letter No. 104, filed on May 22, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add five cellular radiotelephone cell sites to its existing cellular system serving the Los Angeles Metropolitan Area. This Resolution authorizes the construction of five cell sites, known as the Coast, Sunnyslope, Trinity Center, Weir Canyon, and Frazier Mountain sites, located at 20422 Beach Boulevard, Huntington Beach, CA, 7087 Mission Boulevard, Riverside, CA, 1719 South Santee Street, Los Angeles, CA, 180 North Riverview, Suite 215, Anaheim, CA, and Summit Frazier Mountain, Ventura County, respectively. No protests to this Advice Letter have been filed.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption. DISCUSSION

Advice Letter No. 104 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The five sites, Coast, Sunnyslope, Trinity Center, Weir Canyon, and Frazier Mountain, represent additional cellular radiotelephone facilities not described in D.84-04-014, granting LASLP a certificate of public convenience and necessity.

LASLP has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the City of Huntington Beach, the County of Riverside, the City of Los Angelés, the City of Anaheim, the County of Ventura, the United States Department of Agriculture - Forest Service, the Federal Aviation Administration, and the Federal Communications Commission.

The proposed construction for the five cell sites will be Ine proposed construction for the five cell sites will be located at 20422 Beach Boulevard, Huntington Beach, CA, 7087 Mission Boulevard, Riverside, CA, 1719 South Santee Street, Los Angeles, CA, 180 North Riverview, Suite 215, Anaheim, CA, and Summit Frazier Mountain, Ventura County and are known as the Coast, Sunnyslope, Trinity Center, Weir Canyon, and Frazier Mountain sites respectively. The Coast site will consists of microwave and cellular antennas attached to an existing building and an equipment shelter on the fourth floor of that building. The Sunnyslope site consists microwave and cellular antennas mounted to a 90-foot monopole and an equipment shelter. The Trinity Center site consists of microwave and cellular antennas mounted to a 60-foot monopole and an equipment shelter. The Weir Canyon consists of microwave and cellular antennas mounted to the roof of an existing building and an equipment shelter on the second floor of that building. Finally, the Ventura site consists of cellular antennas mounted to an existing tower and installation of of a cell enhancer in an existing equipment shelter.

The five cell sites, Coast, Sunnyslope, Trinity Center, Weir Canyon, and Frazier Mountain, will become part of LASLP's cellular system serving the Los Angeles Metropolitan Area. Resolution T-14501 Effective June 24, 1991 LASLP/A.L. No. 104/JGB

Public notice that LOS ANGELES SMSA LIMITED filed Advice Letter No. 104 requesting authority to construct five cell sites, Coast, Sunnyslope, Trinity Center, Weir Canyon, and Frazier Mountain appeared in the California Public Utilities Commission's May 24, 1991 Daily Calendar. In addition, copies of LASLP's Advice Letter No. 104 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, adjacent utilities either notification, and other interested parties having requested such notification.

PROTESTS

No protests have been filed on LASLP's Advice Letter No. 104.

FINDINGS

- On May 22, 1991, LOS ANGELES SMSA LIMITED filed Advice Letter No. 104 requesting Executive authorization to construct five cell sites, Coast, Sunnyslope, Trinity Center, Weir Canyon, and Frazier Mountain, located at 20422 Beach Boulevard, Huntington Beach, CA, 7087 Mission Boulevard, Riverside, CA, 1719 South Santee Street, Los Angeles, CA, 180 North Riverview, Suite 215, Anaheim, CA, and Summit Frazier Mountain, Ventura County respectively.
- 2. The Coast, Sunnyslope, Trinity Center, Weir Canyon, and Frazier Mountain sites represent additional cellular radiotelephone facilities not described in D.84-04-014, granting LASLP a certificate of public convenience and necessity.
- 3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
- 4. Advice Letter No. 104 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A LASLP officer signed a declaration which states that LASLP has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 104.

- 6. Advice Letter No. 104 lists the following entities which have jurisdiction over the proposed construction of the Coast, Sunnyslope, Trinity Center, Weir Canyon, and Frazier Mountain cell sites: the City of Huntington Beach, the County of Riverside, the City of Los Angeles, the City of Anaheim, the County of Ventura, the United Stated Department of Agriculture, Forest Service, the Federal Aviation Administration, and the Federal Communications Commission.
- 7. No protests to Advice Letter No. 104 have been received.

THEREFORE, IT IS ORDERED that:

- (1) LOS ANGELES SMSA LIMITED'S request for authority to construct five cell sites, Coast, Sunnyslope, Trinity Center, Weir Canyon, and Frazier Mountain, is granted.
- (2) The effective date of this resolution is June 24, 1991.
