R E S O L U T I O N

RESOLUTION T-14565. CAL-ONE CELLULAR LIMITED PARTNERSHIP. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A CELL SITE IN THE HUMBOLDT CELLULAR GEOGRAPHIC SERVICE AREA.

SUMMARY

CAL-ONE CELLULAR LIMITED PARTNERSHIP (Cal-One), by Advice Letter No. 10, filed on June 26, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a new cellular radiotelephone cell site to its existing cellular system serving the Humboldt Cellular Geographic Service Area. This Resolution authorizes the construction of the cell site, known as the Humboldt Hill 2 site, located at 7333 Humboldt Hill Road, Eureka, California 95501. No protests to this Advice Letter have been received.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 10 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The Humboldt Hill 2 site represents an additional cellular radiotelephone facility not described in Decision 91-02-004, granting Cal-One a certificate of public convenience and necessity.

Cal-One has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission); the Federal Aviation Administration, the Federal Communications Commission, and the County of Humboldt.

The proposed construction will be located at 7333 Humboldt Hill Road, Eureka, California 95501 and is known as the Humboldt Hill 2 site. It will consist of cell equipment which will be housed in a building of metal construction painted beige measuring 40 feet long by 8 feet wide by 9 feet high. The building will be located at the base of a 125-foot self-supporting 3-legged tower. Ten-foot antennas will surmount the tower, and 4 microwave dishes will be mounted on the tower, 2 pointed north and 2 pointed south. The property is zoned "unclassified."

The Humboldt Hill 2 site will become part of Cal-One's cellular system serving the Humboldt Cellular Geographic Service Area.

#### NOTICE

Public notice that CAL-ONE CELLULAR LIMITED PARTNERSHIP filed Advice Letter No. 10 requesting authority to construct the Humboldt Hill 2 site appeared in the California Public Utilities Commission's July 1, 1991 Daily Calendar. In addition, copies of Cal-One's Advice Letter No. 10 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

#### PROTESTS

No protests have been received to Cal-One's Advice Letter No. 10.

#### FINDINGS

1. On June 26, 1991, CAL-ONE CELLULAR LIMITED PARTNERSHIP filed Advice Letter No. 10 requesting Executive authorization to construct the Humboldt Hill 2 cell site located at 7333 Humboldt Hill Road, Eureka, California 95501.
2. The Humboldt Hill 2 site represents an additional cellular radiotelephone facility not described in Decision 91-02-004, granting Cal-One a certificate of public convenience and necessity.



3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
4. Advice Letter No. 10 conforms to the requirements of Decision 90-03-080 and G.O. 159.
5. A Cal-One officer signed a declaration which states that Cal-One has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 10.
6. Advice Letter No. 10 lists the following entities which have jurisdiction over the proposed construction of the Humboldt Hill 2 cell site: the Federal Aviation Administration, the Federal Communications Commission, and the County of Humboldt.
7. No protests to Advice Letter No. 10 have been received.

THEREFORE, IT IS ORDERED that:

- (1) CAL-ONE CELLULAR LIMITED PARTNERSHIP's Advice Letter No. 10 is hereby approved.
- (2) The effective date of this resolution is July 26, 1991.
