RESOLUTION

RESOLUTION T-14584. SACRAMENTO VALLEY LIMITED PARTNERSHIP. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF TWO (2) NEW CELL SITES IN THE SACRAMENTO METROPOLITAN STATISTICAL AREA.

BY ADVICE LETTER NO. 63, FILED ON August 7, 1991.

SUMMARY

SACRAMENTO VALLEY LIMITED PARTNERSHIP (SVLP), by Advice Letter No. 63, filed on August 7, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add two (2) new cellular radiotelephone cell sites to its existing cellular system serving the Sacramento Metropolitan Statistical Area. This Resolution authorizes the construction of two (2) new cell sites, known as the River Plaza Drive and Granite Bay sites, located at 2150 River Plaza Drive, Sacramento, California, and 8430 Barton Road, Roseville, California, respectively. No protests to this Advice Letter have been filed.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 63 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The two (2) new sites, River Plaza Drive and Granite Bay, represent additional cellular radiotelephone facilities not described in Decision 85-05-041, granting SVLP a certificate of public convenience and necessity.

SVLP has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the Federal Aviation Administration, the Federal Communications Commission, the City of Sacramento, and the County of Placer.

The proposed construction of the two (2) new cell sites will be in the City of Sacramento and the County of Placer, respectively. The River Plaza Drive cell site will be located at 2150 River Plaza Drive, Sacramento, California. It will consist of cellular radio equipment installed in a 10 feet by 16 feet area of a pre-existing building, an antenna support structure, 3.5 feet in height, which will be attached to the building's penthouse roof area.

The Granite Bay cell site will be located at 8430 Barton Road, Roseville, California. It will consist of cellular radio equipment installed in a pre-existing 12 feet by 24 feet communications shelter and cellular antennas installed on a pre-existing lattice tower.

The two (2) new cell sites, River Plaza Drive and Granite Bay, will become part of SVLP's cellular system serving the Sacramento Metropolitan Statistical Area.

NOTICE

Public notice that SACRAMENTO VALLEY LIMITED PARTNERSHIP filed Advice Letter No. 63 requesting authority to construct two (2) new cell sites, River Plaza Drive and Granite Bay appeared in the California Public Utilities Commission's August 9, 1991 Daily Calendar. In addition, copies of SVLP's Advice Letter No. 63 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been filed on SVLP's Advice Letter No. 63.

FINDINGS

1. On August 7, 1991, SACRAMENTO VALLEY LIMITED PARTNERSHIP filed Advice Letter No. 63 requesting Executive authorization to construct two (2) new cell sites, River Plaza Drive and Granite Bay, located at 2150 River Plaza Drive, Sacramento, California, and 8430 Barton Road, Roseville, California, respectively.

- 2. The River Plaza Drive and Granite Bay sites represent additional cellular radiotelephone facilities not described in Decision 85-05-041, granting SVLP a certificate of public convenience and necessity.
- 3. Décision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
- 4. Advice Letter No. 63 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A SVLP officer signed a declaration which states that SVLP has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 63.
- 6. Advice Letter No. 63 lists the following entities which have jurisdiction over the proposed construction of the River Plaza Drive and Granite Bay cell sites: the Federal Aviation Administration, the Federal Communications Commission, the City of Sacramento, and the County of Placer.
- 7. No protests to Advice Letter No. 63 have been received.

THEREFORE, IT IS ORDERED that:

- (1) SACRAMENTO VALLEY LIMITED PARTNERSHIP's request for authority to construct two (2) new cell sites, River Plaza Drive and Granite Bay, is granted.
- (2) The effective date of this resolution is September 9, 1991.
