R E S O L U T I O N

RESOLUTION T-14604. LOS ANGELES SMSA LIMITED PARTNERSHIP. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF SIX (6) NEW CELL SITES IN THE LOS ANGELES CELLULAR GEOGRAPHIC SERVICE AREA.

BY ADVICE LETTER NO. 112, FILED ON August 14, 1991.

SUMMARY

LOS ANGELES SMSA LIMITED PARTNERSHIP (LASLP), by Advice Letter No. 112, filed on August 14, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add six (6) new cellular radiotelephone cell sites to its existing cellular system serving the Los Angeles Cellular Geographic Service Area. This Resolution authorizes the construction of six (6) new cell sites at the following locations: San Bernardino (South Fontana, County of San Bernardino), 14520 Boyle Avenue, Fontana, California; Los Angeles (Sepulveda Dam, City of Los Angeles), 7136 Haskell Avenue, Van Nuys, California; Los Angeles (Cahuenga Pass, City of Los Angeles), 3518 Cahuenga Pass Boulevard, Los Angeles, California; Whittier (Whitwood, City of Whittier), 15707 Leffingwell Road, Whittier, California; Orange (Villa Park, City of Orange), 1938 East Katella Avenue, Orange, California; Carson (Carson, City of Carson), 550 Carson Plaza Drive, Carson, California. No protests to this Advice Letter have been filed.

BACKGROUND

Under G.O. 159 (Decision 90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 112 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The six (6) new sites, San Bernardino (South Fontana), Los Angeles (Sepulveda Dam), Los Angeles (Cahuenga Pass), Whittier (Whitwood), Orange (Villa Park), and Carson (Carson), represent additional cellular radiotelephone facilities not described in Decision 84-04-014, granting LASLP a certificate of public convenience and necessity.

LASLP has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the Federal Aviation Administration, the Federal Communications Commission, the County of San Bernardino, the City of Los Angeles, the City of Whittier, the City of Orange, and the City of Carson.

The proposed construction of the six (6) new cell sites will be at the following locations and will consist of the respective improvements:

1. San Bernardino (South Fontana, County of San Bernardino), 14520 Boyle Avenue, Fontana, California. Improvements at this site will consist of an 8 foot by 35 foot free-standing cellular communications equipment enclosure to house electrical radio and power equipment. The project also involves placement of two microwave dishes and three faces of cellular antennas attached to a 90 foot monopole.
2. Los Angeles (Sepulveda Dam, City of Los Angeles), 7136 Haskell Avenue, Van Nuys, California. Improvements at this site will consist of a 12 foot by 27 foot underground vault to house electrical radio and power equipment for cellular communications. The project also involves placement of two microwave dishes and three faces of cellular antennas attached to a 60 foot monopole.
3. Los Angeles (Cahuenga Pass, City of Los Angeles), 3518 Cahuenga Pass Boulevard, Los Angeles, California. Improvements at this site will consist of a 410 square foot cellular communications facility on the third floor of an existing three story building. The facility will consist of interior space to house electrical radio and power equipment. The project also involves placement of two microwave antennas and three grids of cellular antennas attached to the penthouse of the building.

4. Whittier (Whitwood, City of Whittier), 15707 Leffingwell Road, Whittier, California. Improvements at this site will consist of a 457 square foot cellular communications facility within an existing single story building. The facility will consist of interior space to house electrical radio and power equipment. The project also involves placement of two microwave antennas and three faces of cellular antennas attached to a 60 foot monopole.
5. Orange (Villa Park, City of Orange), 1938 East Katella Avenue, Orange, California. Improvements at this site will consist of an 8 foot by 35 foot free-standing cellular communications equipment enclosure to house electrical radio and power equipment. The project also involves placement of two microwave dishes and three faces of cellular antennas attached to a 60 foot monopole.
6. Carson (Carson, City of Carson), 550 Carson Plaza Drive, Carson, California. Improvements at this site will consist of a 810 square foot cellular communications facility on the second floor of an existing two story building. The facility will consist of interior space to house electrical radio and power equipment. The project also involves placement of two microwave antennas and faces grids of cellular antennas attached to the roof of the building.

The six (6) new cell sites, San Bernardino (South Fontana), Los Angeles (Sepulveda Dam), Los Angeles (Cahuenga Pass), Whittier (Whitwood), Orange (Villa Park), and Carson (Carson), will become part of LASLP's cellular system serving the Los Angeles Cellular Geographic Service Area.

NOTICE

Public notice that LOS ANGELES SMSA LIMITED PARTNERSHIP filed Advice Letter No. 112 requesting authority to construct six (6) new cell sites, San Bernardino (South Fontana), Los Angeles (Sepulveda Dam), Los Angeles (Cahuenga Pass), Whittier (Whitwood), Orange (Villa Park), and Carson (Carson) appeared in the California Public Utilities Commission's August 16, 1991 Daily Calendar. In addition, copies of LASLP's Advice Letter No. 112 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been filed on LASLP's Advice Letter No. 112.

FINDINGS


1. On August 14, 1991, LOS ANGELES SMSA LIMITED PARTNERSHIP filed Advice Letter No. 112 requesting Executive authorization to construct six (6) new cell sites at the following locations: San Bernardino (South Fontana, County of San Bernardino), 14520 Boyle Avenue, Fontana, California; Los Angeles (Sepulveda Dam, City of Los Angeles), 7136 Haskell Avenue, Van Nuys, California; Los Angeles (Cahuenga Pass, City of Los Angeles), 3518 Cahuenga Pass Boulevard, Los Angeles, California; Whittier (Whitwood, City of Whittier), 15707 Leffingwell Road, Whittier, California; Orange (Villa Park, City of Orange), 1938 East Katella Avenue, Orange, California; Carson (Carson, City of Carson), 550 Carson Plaza Drive, Carson, California.
2. The San Bernardino (South Fontana), Los Angeles (Sepulveda Dam), Los Angeles (Cahuenga Pass), Whittier (Whitwood), Orange (Villa Park), and Carson (Carson) sites represent additional cellular radiotelephone facilities not described in 84-04-014, granting LASLP a certificate of public convenience and necessity.
3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
4. Advice Letter No. 112 conforms to the requirements of Decision 90-03-080 and G.O. 159.
5. A LASLP officer signed a declaration which states that LASLP has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 112.
6. Advice Letter No. 112 lists the following entities which have jurisdiction over the proposed construction of the San Bernardino (South Fontana), Los Angeles (Sepulveda Dam), Los Angeles (Cahuenga Pass), Whittier (Whitwood), Orange (Villa Park), and Carson (Carson) cell sites: the Federal Aviation Administration, the Federal Communications Commission, the County of San Bernardino, the City of Los Angeles, the City of Whittier, the City of Orange, and the City of Carson.
7. No protests to Advice Letter No. 112 have been received.
