<u>R E S O L U T I O N</u>

RESOLUTION T-14611. SACRAMENTO VALLEY LIMITED PARTNERSHIP. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF TWO (2) NEW CELL SITES IN THE SACRAMENTO METROPOLITAN STATISTICAL AREA.

BY ADVICE LETTER NO. 64, FILED ON AUGUST 21, 1991.

SUMMARY

SACRAMENTO VALLEY LIMITED PARTNERSHIP (SVLP), by Advice Letter No. 64, filed on August 21, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add two (2) new cellular radiotelephone cell sites to its existing cellular system serving the Sacramento Metropolitan Statistical Area. This Resolution authorizes the construction of two (2) new cell sites, known as the Consumnes and Patterson sites, located at 8401 Center Parkway, Sacramento, California, and 2789 Eucalyptus Avenue, Patterson, California, respectively. No protests to this Advice Letter have been filed.

BACKGROUND

Under G.O. 159 (Decision 90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 64 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The two (2) new sites, Consumnes and Patterson, represent additional cellular radiotelephone facilities not described in Decision 85-05-041, granting SVLP a certificate of public convenience and necessity. Resolution T-14611 Effective September 23, 1991 SVLP/A.L. No. 64/WSM

SVLP has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the Federal Aviation Administration, the Federal Communications Commission, the City of Sacramento, and the County of Stanislaus.

The proposed construction for the two (2) new cell sites will be located at 8401 Center Parkway, Sacramento, California, and 2789 Eucalyptus Avenue, Patterson, California and are known as the Consumnes and Patterson sites, respectively. The Consumnes site will consist of a 12 foot by 28 foot prefabricated communications shelter which will house cellular equipment and cellular antennas will be mounted on an existing 100 foot communications tower. The Patterson site will consist of a 12 foot by 28 foot prefabricated communications shelter which will house cellular equipment and cellular antennas will be mounted on a pre-existing monopole.

The two (2) new cell sites, Consumnes and Patterson, will become part of SVLP's cellular system serving the Sacramento Metropolitan Statistical Area.

NOTICE

Public notice that SACRAMENTO VALLEY LIMITED PARTNERSHIP filed Advice Letter No. 64 requesting authority to construct two (2) new cell sites, Consumnes and Patterson appeared in the California Public Utilities Commission's August 26, 1991 Daily Calendar. In addition, copies of SVLP's Advice Letter No. 64 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been filed on SVLP's Advice Letter No. 64.

FINDINGS

 On August 21, 1991, SACRAMENTO VALLEY LIMITED PARTNERSHIP filed Advice Letter No. 64 requesting Executive authorization to construct two (2) new cell sites, Consumnes and Patterson, located at 8401 Center Parkway, Sacramento, California, and 2789 Bucalyptus Avenue, Patterson, California, respectively. Resolution T-14611 Effective September 23, 1991 SVLP/A.L. No. 64/WSM

- 2. The Consumnes and Patterson sites represent additional cellular radiotelephone facilities not described in Decision 85-05-041, granting SVLP a certificate of public convenience and necessity.
- 3. Decisión 90-03-080 adopts G.O. 159 which sets forth cértain requiréments for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
- 4. Advice Letter No. 64 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A SVLP officer signed a declaration which states that SVLP has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 64.
- 6. Advice Letter No. 64 lists the following entities which have jurisdiction over the proposed construction of the Consumnes and Patterson cell sites: the Federal Aviation Administration, the Federal Communications Commission, the City of Sacramento, and the County of Stanislaus.
- 7. No protests to Advice Letter No. 64 have been received.

THEREFORE, IT IS ORDERED that:

- SACRAMENTO VALLEY LIMITED PARTNERSHIP's request for authority to construct two (2) new cell sites, Consumnes and Patterson, is granted.
- (2) The effective date of this resolution is September 23, 1991.
