RESOLUTION T-14625. US WEST CELLULAR OF CALIFORNIA, INC.. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A CELL SITE IN THE SAN DIEGO CELLULAR GEOGRAPHIC SERVICE AREA.

SUMMARY

US WEST CELLULAR OF CALIFORNIA, INC. (US WEST), by Advice Letter No. 56, filed on August 29, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a cellular radiotelephone cell site to its existing cellular system serving the San Diego Cellular Geographic Service Area. This Resolution authorizes the construction of the cell site, known as the Poway site, located at 12544 Kirkham Court, Poway CA. No protests to this Advice Letter have been received.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 56 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The Poway site represents an additional cellular radiotelephone facility not described in Decision 85-12-023, granting US WEST a certificate of public convenience and necessity.

US WEST has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the Federal Communications Commission, the Federal Aviation Administration, and the City of Poway.

The proposed construction will be located at 12544 Kirkham Court, Poway CA and is known as the Poway site. It will consist of six cellular antennas mounted on the rooftop of an existing one-story commercial building and communication equipment, DC powerplant, and batteries installed within an existing space.

The Poway site will become part of US WEST's cellular system serving the San Diego Cellular Geographic Service Area.

NOTICE

Public notice that US WEST CELLULAR OF CALIFORNIA, INC. filed Advice Letter No. 56 requesting authority to construct the Poway site appeared in the California Public Utilities Commission's September 6, 1991 Daily Calendar. In addition, copies of US WEST's Advice Letter No. 56 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been received to US WEST's Advice Letter No. 56.

FINDINGS

- On August 29, 1991, US WEST CELLULAR OF CALIFORNIA, INC. filed Advice Letter No. 56 requesting Executive authorization to construct Poway site located at 12544 Kirkham Court, Poway CA.
- 2. The Poway site représents an additional cellular radiotelephone facility not described in Decision 85-12-023, granting US WEST a certificate of public convenience and necessity.
- 3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.

- 4. Advice Letter No. 56 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A US WEST officer signed a declaration which states that US WEST has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 56.
- 6. Advice Letter No. 56 lists the following entities which have jurisdiction over the proposed construction of the Poway site: the Federal Communications Commission, the Federal Aviation Administration, and the City of Poway.
- 7. No protests to Advice Letter No. 56 have been received.

THEREFORE, IT IS ORDERED that:

- (1) US WEST CELLULAR OF CALIFORNIA, INC.'s Advice Letter No. 56 is hereby approved.
- (2) The effective date of this resolution is September 30, 1991.
