RESQLUTION

RESOLUTION T-14655. ORDER REVOKING THE CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY GRANTED TO CELLULAR DATA.

BY ADVICE LETTER NO. 7, FILED ON AUGUST 26, 1991.

SUMMARY

By Advice Letter No. 7 filed on August 26, 1991, Cellular Data requests authority under the provisions of General Order No. 96-A, Section XIV, to withdraw its cellular reseller service.

This Resolution grants Cellular Data's request to withdraw its cellular reseller service. There were no protests filed to this Advice Letter. Cellular Data has no customers.

BACKGROUND

Cellular Data (CD) filed Application 84-05-059 on May 15, 1984 requesting authorization to provide cellular reseller service in the greater Los Angeles metropolitan area. There were no protests to CD's application. The Commission determined that CD had the ability, experience, equipment, and financial resources to perform the proposed service.

The Commission granted a certificate of public convenience and necessity to CD in Decision 84-07-118, dated July 18, 1991. CD was assigned the corporate identification number U-4010-C.

CD filed Advice Letter No. 7 with the Commission Advisory and Compliance Division (CACD) on August 26, 1991 indicating that CD is no longer operating as a cellular reseller and has no customers.

NOTICE/PROTEST

Notice of this Advice Letter appeared on the Commission's Daily Calendar of August 30, 1991. No protests to the Advice Letter were received.

DISCUSSION

Under General Order No. 96-A, Section XIV, a utility may not withdraw from service without Commission authorization. Section XIV states:

"No public utility of a class specified herein shall, unless authority has been obtained from the Commission, either withdraw entirely from public service or withdraw from public service in any portion of the territory served."

By filing Advice Letter No. 7, CD appropriately requested that its authorization be withdrawn. The Commission approves CD's request and revokes its certificate.

FINDINGS

- 1. Cellular Data was granted a certificate of public convenience and necessity to operate as a cellular reseller in Decision 84-07-118.
- 2. Cellular Data submitted Advice Letter No. 7 requesting authority to withdraw its cellular reseller service.
- 3. Cellular Data has no customers.

THEREFORE, IT IS ORDERED that:

- 1. The Certificate of Public Convenience and Necessity previously granted to Cellular Data is revoked.
- 2. A copy of this Resolution shall be placed in the Commission's formal file for Application No. 84-05-059.
- 3. Cellular Data's cellular reseller tariffs are cancelled. The CPUC Corporate Identification Number U-4010-C is also cancelled and will not be reissued.
