RESOLUTION T-14769. BAY AREA CELLULAR TELEPHONE COMPANY. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A CELL SITE IN THE SAN FRANCISCO/OAKLAND/SAN JOSE CELLULAR GEOGRAPHIC SERVICE AREA.

BAY AREA CELLULAR TELEPHONE COMPANY (BACTC), by Advice Letter No. 128, filed on December 4, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a cellular radiotelephone cell site to its existing cellular system serving the San Francisco/Oakland/San Jose Cellular Geographic Service Area. This Resolution authorizes the construction of the cell site, known as the Dublin Grade site, located at 6390 Grassland Drive, Castro Valley, California, on a large residential lot (APN 85A-1400-1-5). The site is approximately 300 feet northwest of an existing house, and adjacent to an existing GTE Mobilnet cellular communications facility. No protests to this Advice Letter have been received.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 128 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The Dublin Grade site represents an additional cellular radiotelephone facility not described in Decision 86-05-010, granting BACTC a certificate of public convenience and necessity.

BACTC has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the Federal Aviation Administration, the Federal Communications Commission, and the County of Alameda.

The proposed construction will be located at 6390 Grassland Drive, Castro Valley, California, on a large residential lot (APN 85A-1400-1-5). The site is approximately 300 feet northwest of an existing house, adjacent to an existing GTE Mobilnet cellular communications facility, and is known as the Dublin Grade site. It will consist of an approximately 210 square foot equipment shelter and six cellular antennas mounted on a twenty-five foot wooden utility pole. The shelter will have a footing pad type foundation which will extend approximately sixteen inches below ground and eight inches above ground level. The utility pole will be placed approximately 100 feet east of the shelter. Power will be supplied from an existing PG&E power pole and fed to the equipment shelter through approximately 125 feet of underground cable.

The Dublin Grade site will become part of BACTC's cellular system serving the San Francisco/Oakland/San Jose Cellular Geographic Service Area.

NOTICE

Public notice that BAY AREA CELLULAR TELEPHONE COMPANY filed Advice Letter No. 128 requesting authority to construct the Dublin Grade site appeared in the California Public Utilities Commission's December 6, 1991 Daily Calendar. In addition, copies of BACTC's Advice Letter No. 128 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been received to BACTC's Advice Letter No. 128.

FINDINGS

- On December 4, 1991, BAY AREA CELLULAR TELEPHONE COMPANY filed Advice Letter No. 128 requesting Executive authorization to construct Dublin Grade site located at 6390 Grassland Drive, Castro Valley, California, on a large residential lot. The site is approximately 300 feet northwest of an existing house (APN 85A-1400-1-5), and adjacent to an existing GTE Mobilnet cellular communications facility.
- The Dublin Grade site represents an additional cellular radiotelephone facility not described in Decision 86-05-010, granting BACTC a certificate of public convenience and necessity.
- 3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
- 4. Advice Letter No. 128 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A BACTC officer signed a declaration which states that BACTC has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 128.
- 6. Advice Letter No. 128 lists the following entities which have jurisdiction over the proposed construction of the Dublin Grade site: the Federal Aviation Administration, the Federal Communications Commission, and the County of Alameda.
- 7. No protests to Advice Letter No. 128 have been received.

THEREFORE, IT IS ORDERED that:

- (1) BAY AREA CELLULAR TELEPHONE COMPANY'S Advice Letter No. 128 is hereby approved.
- (2) The effective date of this resolution is January 6, 1992.
