RESQLUTION

RESOLUTION T-14774. FRESNO CELLULAR TELEPHONE COMPANY. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A CELL SITE IN THE FRESNO METROPOLITAN SERVICE AREA.

BY ADVICE LETTER NO. 43, FILED ON DECEMBER 12, 1991.

SUMMARY

FRESNO CELLULAR TELEPHONE COMPANY (FCTC), by Advice Letter No. 43, filed on December 12, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a cellular radiotelephone cell site to its existing cellular system serving the Fresno Metropolitan Service Area. This Resolution authorizes the construction of the cell site, known as the Madera site, located at 40457 #A Avenue 10, Madera. No protests to this Advice Letter have been received.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the commission's preemption.

DISCUSSION

Advice Letter No. 43 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The Madera site represents an additional cellular radiotelephone facility not described in Decision 87-10-036, granting FCTC a certificate of public convenience and necessity.

FCTC has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities commission): the Federal Communications Commission, the Federal Aviation Administration, and the County of Madera.

The proposed construction will be located at 40457 #A Avenue 10, Madera and is known as the Madera site. It will consist of a 12-foot by 28-foot modular building, a 150-foot self-supporting lattice tower, 12 cellular antennas, four microwave antennas, an emergency generator, and communication equipment.

The Madera site will become part of FCTC's cellular system serving the Fresno Metropolitan Service Area.

NOTICE

Public notice that FRESNO CELLULAR TELEPHONE COMPANY filed Advice Letter No. 43 requesting authority to construct the Madera site appeared in the California Public Utilities Commission's December 11, 1991 Daily Calendar. In addition, copies of FCTC's Advice Letter No. 43 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been received to FCTC's Advice Letter No. 43.

FINDINGS

- 1. On December 12, 1991, FRESNO CELLULAR TELEPHONE COMPANY filed Advice Letter No. 43 requesting Executive authorization to construct Madera site located at 40457 #A Avenue 10, Madera.
- 2. The Madera site represents an additional cellular radiotelephone facility not described in Decision 87-10-036, granting FCTC a certificate of public convenience and necessity.
- 3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.

- 4. Advice Letter No. 43 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A FCTC officer signed a declaration which states that FCTC has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 43.
- 6. Advice Letter No. 43 lists the following entities which have jurisdiction over the proposed construction of the Madera site: the Federal Communications Commission, the Federal Aviation Administration, and the County of Madera.
- 7. No protests to Advice Letter No. 43 have been received.

THEREFORE, IT IS ORDERED that:

- (1) FRESNO CELLULAR TELEPHONE COMPANY'S Advice Letter No. 43 is hereby approved.
- (2) The effective date of this resolution is January 9, 1992.
