R E S O L U T I O N

RESOLUTION T-14810. BAKERSFIELD CELLULAR TELEPHONE COMPANY. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A CELL SITE IN THE BAKERSFIELD CELLULAR GEOGRAPHIC SERVICE AREA.

BY ADVICE LETTER NO. 23, FILED ON DECEMBER 24, 1991.

SUMMARY

BAKERSFIELD CELLULAR TELEPHONE COMPANY (BAKERSFIELD), by Advice Letter No. 23, filed on December 24, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a cellular radiotelephone cell site to its existing cellular system serving the Bakersfield Cellular Geographic Service Area. This Resolution authorizes the construction of the cell site, known as the Site # 10 site, located at 801 W. Ridgecrest Blvd, Ridgecrest, CA 93555. No protests to this Advice Letter have been received.

BACKGROUND

Under G.O. 159 (D.90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 23 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The Site # 10 site represents an additional cellular radiotelephone facility not described in Decision 88-05-024, granting BAKERSFIELD a certificate of public convenience and necessity.

BAKERSFIELD has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): No local permits required, FAA, FCC.

The proposed construction will be located at 801 W. Ridgecrest Blvd, Ridgecrest, CA 93555 and is known as the Site # 10 site. It will consist of minor construction. 3 omni-antennas will be mounted on an existing 240' wind charger tower. Cellular radiotelephone equipment will be housed in an existing building.

The Site # 10 site will become part of BAKERSFIELD's cellular system serving the Bakersfield Cellular Geographic Service Area.

NOTICE

Public notice that BAKERSFIELD CELLULAR TELEPHONE COMPANY filed Advice Letter No. 23 requesting authority to construct the Site # 10 site appeared in the California Public Utilities Commission's December 30, 1991 Daily Calendar. In addition, copies of BAKERSFIELD's Advice Letter No. 23 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been received to BAKERSFIELD's Advice Letter No. 23.

FINDINGS

1. On December 24, 1991, BAKERSFIELD CELLULAR TELEPHONE COMPANY filed Advice Letter No. 23 requesting Executive authorization to construct Site # 10 site located at 801 W. Ridgecrest Blvd, Ridgecrest, CA 93555.
2. The Site # 10 site represents an additional cellular radiotelephone facility not described in Decision 88-05-024, granting BAKERSFIELD a certificate of public convenience and necessity.
3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.



4. Advice Letter No. 23 conforms to the requirements of Decision 90-03-080 and G.O. 159.
5. A BAKERSFIELD officer signed a declaration which states that BAKERSFIELD has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 23.
6. Advice Letter No. 23 lists the following entities which have jurisdiction over the proposed construction of the Site # 10 site: No local permits required, FAA, FCC.
7. No protests to Advice Letter No. 23 have been received.

THEREFORE, IT IS ORDERED that:

- (1) BAKERSFIELD CELLULAR TELEPHONE COMPANY's Advice Letter No. 23 is hereby approved.
- (2) The effective date of this resolution is January 24, 1992.
