R E S O L U T I O N

RESOLUTION T-14811. SACRAMENTO-VALLEY LIMITED PARTNERSHIP. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF TWO NEW CELL SITES IN THE SACRAMENTO-VALLEY METROPOLITAN AREA.

BY ADVICE LETTER NO. 74, FILED ON NOVEMBER 15, 1991.

SUMMARY

SACRAMENTO-VALLEY LIMITED PARTNERSHIP (SLVP), by Advice Letter No. 74, filed on November 15, 1991, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add two new cellular radiotelephone cell sites to its existing cellular system serving the Sacramento-Valley Metropolitan Area. This Resolution authorizes the construction of two new cell sites, known as the County Club Centre and Olivehurst sites, located at 3382 El Camino Avenue, Room 31, Sacramento, CA and 3359 Forty Mile Road, Marysville, CA, respectively. No protests to this Advice Letter have been filed.

BACKGROUND

Under G.O. 159 (Decision 90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 74 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The two new sites, County Club Centre and Olivehurst, represent additional cellular radiotelephone facilities not described in Decision 85-05-041, granting SLVP a certificate of public convenience and necessity.

SLVP has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the Counties of Sacramento and Yuba, the Federal Aviation Administration, and the Federal Communications Commission.

The proposed construction for the two new cell sites will be located at 3382 El Camino Avenue, Room 31, Sacramento, CA and 3359 Forty Mile Road, Marysville, CA and are known as the County Club Centre and Olivehurst sites, respectively. The County Club Centre site will consist of three directional antennas mounted on a 3.5-foot support attached to the roof of an existing building and an equipment shelter. The Olivehurst site will consist of four whip antennas mounted on a 150-foot tower and an equipment shelter.

The two new cell sites, County Club Centre and Olivehurst, will become part of SLVP's cellular system serving the Sacramento-Valley Metropolitan Area.

NOTICE

Public notice that SACRAMENTO-VALLEY LIMITED PARTNERSHIP filed Advice Letter No. 74 requesting authority to construct two new cell sites, County Club Centre and Olivehurst appeared in the California Public Utilities Commission's November 20, 1991 Daily Calendar. In addition, copies of SLVP's Advice Letter No. 74 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been filed on SLVP's Advice Letter No. 74.

FINDINGS

1. On November 15, 1991, SACRAMENTO-VALLEY LIMITED PARTNERSHIP filed Advice Letter No. 74 requesting Executive authorization to construct two new cell sites, County Club Centre and Olivehurst, located at 3382 El Camino Avenue, Room 31, Sacramento, CA and 3359 Forty Mile Road, Marysville, CA, respectively.
2. The County Club Centre and Olivehurst sites represent additional cellular radiotelephone facilities not described in 85-05-041, granting SLVP a certificate of public convenience and necessity.

3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.
4. Advice Letter No. 74 conforms to the requirements of Decision 90-03-080 and G.O. 159.
5. A SLVP officer signed a declaration which states that SLVP has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 74.
6. Advice Letter No. 74 lists the following entities which have jurisdiction over the proposed construction of the County Club Centre and Olivehurst cell sites: the Counties of Sacramento and Yuba, the Federal Aviation Administration, and the Federal Communications Commission.
7. No protests to Advice Letter No. 74 have been received.

THEREFORE, IT IS ORDERED that:

- (1) SACRAMENTO-VALLEY LIMITED PARTNERSHIP's request for authority to construct two new cell sites, County Club Centre and Olivehurst, is granted.
- (2) The effective date of this resolution is December 16, 1991.
