RESQLUTION

RESOLUTION T-14818. RANDOLPH CELLULAR LIMITED PARTNERSHIP dba NORTH COAST CELLULAR. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF A CELL SITE IN THE DEL NORTE, SISKIYOU, HUMBOLDT, AND TRININTY RURAL SERVICE AREA.

BY ADVICE LETTER NO. 14, FILED ON JANUARY 8, 1992.

SUMMARY

RANDOLPH CELLULAR LIMITED PARTNERSHIP dba NORTH COAST CELLULAR (NCC), by Advice Letter No. 14, filed on January 8, 1992, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add a cellular radiotelephone cell site to its existing cellular system serving the Del Norte, Siskiyou, Humboldt, and Trininty Rural Service Area. This Resolution authorizes the construction of the cell site, known as the McKinleyville site, located at 3370 Murray Road, McKinleyville, CA. No protests to this Advice Letter have been received.

BACKGROUND

Under G.O. 159, a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 14 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The McKinleyville site represents an additional cellular radiotelephone facility not described in Decision 90-01-011, granting NCC a certificate of public convenience and necessity.

NCC has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the County of Humboldt, the Federal Aviation Administration, and the Federal Communications Commission.

The proposed construction will be located at 3370 Murray Road, McKinleyville, CA, and is known as the McKinleyville site. It will consist of an ASPD 958 antenna mounted on an existing 250-foot guyed tower.

The McKinleyville site will become part of NCC's cellular system serving the Del Norte, Siskiyou, Humboldt, and Trininty Rural Service Area.

NOTICE

Public notice that RANDOLPH CELLULAR LIMITED PARTNERSHIP dba NORTH COAST CELLULAR filed Advice Letter No. 14 requesting authority to construct the McKinleyville site appeared in the California Public Utilities Commission's January 15, 1992, Daily Calendar. In addition, copies of NCC's Advice Letter No. 14 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests to NCC's Advice Letter No. 14 have been received.

FINDINGS

- On January 8, 1992, RANDOLPH CELLULAR LIMITED PARTNERSHIP dba NORTH COAST CELLULAR filed Advice Letter No. 14 requesting Executive authorization to construct the McKinleyville site located at 3370 Murray Road, McKinleyville, CA.
- 2. The McKinleyville site represents an additional cellular radiotelephone facility not described in Decision 90-01-011, granting NCC a certificate of public convenience and necessity.
- Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone facilities not described in a utility's certificate of public convenience and necessity.

- 4. Advice Letter No. 14 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A NCC officer signed a declaration which states that NCC has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 14.
- 6. Advice Letter No. 14 lists the following entities which have jurisdiction over the proposed construction of the McKinleyville site: the County of Humboldt, the Federal Aviation Administration, and the Federal Communications Commission.
- 7. No protests to Advice Letter No. 14 have been received.

THEREFORE, IT IS ORDERED that:

- (1) RANDOLPH CELLULAR LIMITED PARTNERSHIP dba NORTH COAST CELLULAR'S Advice Letter No. 14 is hereby approved.
- (2) The effective date of this resolution is February 10, 1992.
