RESQLUTION

RESOLUTION T-14853. SACRAMENTO-VALLEY LIMITED PARTNERSHIP. EXECUTIVE ORDER AUTHORIZING THE ADDITION OF TWO NEW CELL SITES IN THE SACRAMENTO-VALLEY METROPOLITAN AREA.

BY ADVICE LETTER NO. 78, FILED ON JANUARY 13, 1992.

SUMMARY



SACRAMENTO-VALLEY LIMITED PARTNERSHIP (SVLP), by Advice Letter No. 78, filed on January 13, 1992, requests authority under the provisions of General Order 159 (G.O. 159) and Decision No. 90-03-080 (March 28, 1990) to add two new cellular radiotelephone cell sites to its existing cellular system serving the Sacramento-Valley Metropolitan Area. This Resolution authorizes the construction of two new cell sites, known as the Salida and Hatch sites, located at 4800 Sisk Road, Modesto, CA and 1301 Rockerfeller Drive, Ceres, CA, respectively. No protests to this Advice Letter have been filed.

BACKGROUND

Under G.O. 159 (Decision 90-03-080), a cellular utility must obtain authorization from the Commission before construction of cellular facilities not described in the decision granting the certificate of public convenience and necessity. A cellular utility must file an advice letter requesting authorization to construct after it has received all approvals for the proposed construction required by any governmental agencies with jurisdiction over the proposed construction, or which would have jurisdiction absent the Commission's preemption.

DISCUSSION

Advice Letter No. 78 contains all the information required under G.O. 159 to be included in an Advice Letter filing for authority to construct additional cellular facilities.

The two new sites, Salida and Hatch, represent additional cellular radiotelephone facilities not described in Decision 85-05-041, granting SVLP a certificate of public convenience and necessity.

SVLP has obtained permits or approvals from the following governmental entities and asserts that these entities comprise all governmental entities that have jurisdiction over the proposed construction (with the exception of the California Public Utilities Commission): the County of Stanislaus, the City of Ceres, the Federal Aviation Administration, and the Federal Communications Commission.

The proposed construction for the two new cell sites will be located at 4800 Sisk Road, Modesto, CA and 1301 Rockerfeller Drive, Ceres, CA and are known as the Salida and Hatch sites, respectively. The Salida and Hatch sites will each consist of four cellular antennas and one microwave dish mounted to a 100 foot monopole and a 12 by 28 foot equipment shelter.

The two new cell sites, Salida and Hatch, will become part of SVLP's cellular system serving the Sacramento-Valley Metropolitan Area.

NOTICE

Public notice that SACRAMENTO-VALLEY LIMITED PARTNERSHIP filed Advice Letter No. 78 requesting authority to construct two new cell sites, Salida and Hatch appeared in the California Public Utilities Commission's January 15, 1992 Daily Calendar. In addition, copies of SVLP's Advice Letter No. 78 were mailed in accordance with the Commission's General Order No. 96-A, Section III. G, to competing utilities either privately or publicly owned, adjacent utilities either privately or publicly owned, utilities having requested such notification, and other interested parties having requested such notification.

PROTESTS

No protests have been filed on SVLP's Advice Letter No. 78.

FINDINGS

- 1. On January 13, 1992, SACRAMENTO-VALLEY LIMITED PARTNERSHIP filed Advice Letter No. 78 requesting Executive authorization to construct two new cell sites, Salida and Hatch, located at 4800 Sisk Road, Modesto, CA and 1301 Rockerfeller Drive, Ceres, CA, respectively.
- 2. The Salida and Hatch sites represent additional cellular radiotelephone facilities not described in 85-05-041, granting SVLP a certificate of public convenience and necessity.
- 3. Decision 90-03-080 adopts G.O. 159 which sets forth certain requirements for the filing of advice letters requesting authorization to construct cellular radiotelephone

facilities not described in a utility's certificate of public convenience and necessity.

- 4. Advice Letter No. 78 conforms to the requirements of Decision 90-03-080 and G.O. 159.
- 5. A SVLP officer signed a declaration which states that SVLP has received all necessary permits or approvals from the governmental entities listed in Advice Letter No. 78.
- 6. Advice Letter No. 78 lists the following entities which have jurisdiction over the proposed construction of the Salida and Hatch cell sites: the County of Stanislaus, the City of Ceres, the Federal Aviation Administration, and the Federal Communications Commission.
- 7. No protests to Advice Letter No. 78 have been received.

THEREFORE, IT IS ORDERED that:

- (1) SACRAMENTO-VALLEY LIMITED PARTNERSHIP's request for authority to construct two new cell sites, Salida and Hatch, is granted.
 - (2) The effective date of this resolution is February 13, 1992.
