# RESQLUTION

RESOLUTION T-15136. REQUEST BY PACIFIC BELL (U-1001-C) FOR EXTENSION OF PROVISIONAL AUTHORITY FOR ITS PROMOTIONAL PRICING TARIFF.

BY ADVICE LETTER NO. 16324, FILED ON SEPTEMBER 1, 1992.

## SUMMARY

On September 1, 1992, Pacific Bell (Pacific) filed Advice Letter No. 16324 requesting a six-month extension of the provisional authority for Promotional Pricing, Tariff Schedule Cal. P.U.C. No. A5, Exchange Services. This Resolution grants Pacific's request for a renewal of provisional authority for its Promotional Pricing tariff until April 6, 1993.

## BACKGROUND

On October 12, 1990, Resolution T-14174 granted Pacific two-year provisional authority to offer Promotional Pricing. The authority for Pacific's Promotional Pricing tariff will expire on October 12, 1992.

Pacific has also submitted a proposed filing requesting the expansion of and permanent authority for Promotional Pricing. The Commission Advisory and Compliance Division (CACD) is currently reviewing this proposal.

## PROTESTS

Notice of Advice Letter No. 16324 was published in the Commission Calendar on September 4, 1992. CACD has received no protest to Pacific's Advice Letter No. 16324.

#### DISCUSSION

CACD has reviewed Advice Letter No. 16324. CACD recognizes that Pacific's Promotional Pricing authority will expire on October 12, 1992, and needs to be renewed. CACD, based upon Pacific's proposed filing, believes that Pacific will be able to file for

permanent authority within the next six months. Therefore, CACD recommends re-authorizing Pacific's Promotional Pricing provisional authority until April 6, 1993.

### FINDINGS

- 1. On September 1, 1992, Pacific Bell filed Advice Letter No. 16324 requesting a six-month extension of its Promotional Pricing authority for which it was granted provisional authority by Commission Resolution T-14174.
- 2. After reviewing Advice Letter No. 16324, CACD recommends a six-month provisional re-authorization of Pacific Bell's Promotional Pricing authority.

THEREFORE, IT IS ORDERED that:

1. Pacific Bell is granted authority to offer Promotional Pricing programs on a provisional basis under the same conditions granted in Commission Resolution T-14174 until April 6, 1993.

The effective date of this Resolution is today.
