R E S O L U T I O N

RESOLUTION T-15744. REQUEST OF INLAND DESERT SECURITY & COMMUNICATIONS, INC. TO HAVE ITS CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY REVOKED.

SUMMARY

Inland Desert Security & Communications, Inc., by letter dated January 5, 1995, requests authority to withdraw from service as a radio telephone utility (RTU). This resolution revokes the company's Certificate of Public Convenience and Necessity. The company has no current customers; therefore, no customers will be inconvenienced by the company's withdrawal of service.

BACKGROUND

Inland Desert Security and Communications, Inc. was granted its Certificate of Public Convenience and Necessity (CPCN) by D.84-11-013 effective on December 7, 1984, to operate as a radio telephone utility (RTU). Its tariff was filed on September 12, 1985, and made effective on September 22, 1985.

DISCUSSION

Inland Desert Security and Communications, Inc. informed the Commission by letter dated January 5, 1995, that it is no longer acting as a radio telephone utility. The Commission Advisory and Compliance Division recommends that the CPCN be revoked as requested and that the Corporate Identification Number (U-2066-C) be cancelled.

FINDINGS

1. Inland Desert Security and Communications, Inc. was granted a Certificate of Public Convenience and Necessity (CPCN) as a radio telephone utility (RTU) in Decision 84-11-013.
2. The company requests revocation of its CPCN by letter dated January 5, 1995.

3. The company's CPCN should be revoked. Its Corporate Identification Number should be cancelled.

THEREFORE, IT IS ORDERED that:


1. The Certificate of Public Convenience and Necessity previously granted to Inland Desert Security & Communications, Inc. is revoked.

2. A copy of this Resolution shall be placed in the Commission's formal files for Application No. 84-08-046.

3. The company's California Public Utilities Commission Corporate Identification Number, U-2066-C, is cancelled and will not be reissued.
