R E S O L U T I O N

RESOLUTION T-15802, REQUEST OF S.G.H. TELECOMMUNICATIONS
(DBA ROCKWELL COMMUNICATIONS) TO HAVE ITS CERTIFICATE OF
PUBLIC CONVENIENCE AND NECESSITY REVOKED.

SUMMARY

S.G.H. Telecommunications, Inc. (dba Rockwell Communications), by letter dated June 27, 1995, informed the Commission that it has withdrawn from all operations in California as a non-dominant interexchange carrier (NDIEC). This Resolution revokes the company's Certificate of Public Convenience and Necessity (CPCN). The company has no current customers, therefore, no customers will be inconvenienced by the company's withdrawal of service.

BACKGROUND

Rockwell Communications was granted its CPCN by D.94-03-023 effective on March 9, 1994, to operate as an NDIEC. Its tariff was filed on March 21, 1994, and made effective on March 22, 1994.

DISCUSSION

Rockwell Communications informed the Commission by letter dated June 27, 1995, that it is no longer acting as an NDIEC. The Commission Advisory and Compliance Division recommends that the CPCN be revoked as requested and that the Corporate Identification Number (U-5369-C) be cancelled.

FINDINGS

1. Rockwell Communications was granted a CPCN as a nondominant interexchange carrier by Decision 94-03-023.
2. The company informed the Commission of its cessation of telecommunications operations by letter dated June 27, 1995.

3. The company's CPCN should be revoked. Its Corporate Identification Number should be cancelled.

THEREFORE, IT IS ORDERED that:

1. The Certificate of Public Convenience and Necessity previously granted to S.G.H. Telecommunications, Inc. (dba Rockwell Communications) is revoked.
2. A copy of this Resolution shall be placed in the Commission's formal files for Application No.93-08-054.
3. The company's California Public Utilities Commission Corporate Identification Number, U-5369-C, is cancelled and will not be reissued.

The effective date of this Resolution is today.
