RESOLUTION

RESOLUTION T-15825. EVANS TELEPHONE COMPANY. (U-1008-C). EXECUTIVE ORDER CORRECTING ERROR IN DEPRECIATION RATE TABLE A CONTAINED IN RESOLUTION NO. T-15608, SEPTEMBER 1, 1994.

SUMMARY

Table A to this Resolution corrects errors in proposed depreciation rates adopted in Resolution T-15608, September 1, 1994, for Evans Telephone Company.

BACKGROUND

On September 1, 1994, by Resolution No. T-15608, the Commission adopted proposed depreciation rates for Evans Telephone Company. Table A, attached to Resolution No. T-15608, contained the proposed depreciation rate. The depreciation rate is expressed as the adopted accrual amount and as a percentage of gross plant for each account.

Recently it was discovered that while the adopted accrual amounts are correct for each outside plant account in Table A, the depreciation rate was calculated incorrectly for Account Nos. 2421 - Aerial Cable, 2422 - Underground Cable, 2423, Buried Cable, 2431 - Aerial Wire, and 2441 - Underground Conduit.

Table A of Resolution No. T-15608 listed the depreciation rates for these accounts as: No. 2421 - 11.33%, No. 2422 - 10.29%, No. 2423 - 9.80%, No. 2431 - 21.58%, and No. 2441 - 9.46%. The correct depreciation rates are: No. 2421 - 10.48%, No. 2422 - 8.80%, No. 2423 - 7.79%, No. 2431 - 85.28%, and No. 2441 - 8.59%.

Table A to this Resolution No. T-15825 contains the corrected rates.

DISCUSSION

Resolution A-4661, dated March 9, 1977, ordered that the Executive Director is authorized to sign, "...on behalf of the Commission, orders involving the correction of typographical and clerical errors, and other obvious, inadvertent errors and omissions in the decisions and orders of the Commission." Further, "Each such corrective order, when signed and filed by the Executive Director, shall be deemed to be the order of the Commission."
