R E S O L U T I O N

RESOLUTION T-15953. REQUEST OF REALCOM OFFICE COMMUNICATIONS, INC. TO HAVE ITS CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY REVOKED.

SUMMARY

Realcom Office Communications, Inc., by Advice Letter No. 15, requested authority to withdraw from service as a nondominant interexchange carrier.

BACKGROUND

Realcom Office Communications, Inc. (U-5091-C) applied for a Certificate of Public Convenience and Necessity (CPCN), under the company name SBS Real Estate Communications, Inc., to operate as a nondominant interexchange carrier in A.85-04-107 (April 1985). The CPCN was granted by D.85-07-083 on July 24, 1985. Through ownership transfers the carrier became Realcom Office Communications, Inc. in September 1992.

DISCUSSION

Realcom Office Communications, Inc. requested revocation of its CPCN by Advice Letter No. 15, which was received on June 6, 1996. The Commission Advisory and Compliance Division recommends that the company's CPCN be revoked as requested and that its Corporate Identification Number be cancelled.

FINDINGS

1. Realcom Office Communications, Inc. was granted a Certificate of Public Convenience and Necessity (CPCN) as a nondominant interexchange carrier by Decision 85-07-083.
2. Realcom Office Communications, Inc. requested revocation of its CPCN in Advice Letter No. 15, which was received on June 6, 1996. No customers will be inconvenienced because they were offered service with MFS Intelenet, an affiliate of Realcom Office Communications, Inc., without interruption or additional cost of service.

3. Realcom Office Communications, Inc's CPCN should be revoked. Its Corporate Identification Number should be cancelled.

THEREFORE, IT IS ORDERED that:


1. The Certificate of Public Convenience and Necessity previously granted to Realcom Office Communications, Inc. is revoked.

2. A copy of this Resolution shall be placed in the Commission's formal files for Application No. 85-04-107.

3. Realcom Office Communications, Inc.'s California Public Utilities Commission Corporate Identification Number, U-5091-C, is cancelled and will not be reissued.

The effective date of this Resolution is today.
