SUMMARY

The present rates of twelve small local exchange telephone companies (SMLECs) listed in appendix A are made subject to refund/recovery effective January 1, 1997, pending final Commission action by Resolution on individual general rate case (GRC) advice letters filed by the utilities in December 1995. Refund or recovery of any revenue requirement change authorized by final Commission Resolution for each company may be

accomplished by revised rates and/or a general surcredit/surcharge on each company's ratepayers.

BACKGROUND -

Decision No. 94-09-065, Ordering Paragraph No. 45, required all SMLECs to file GRCs on or before December 31, 1995. General Order 96-A, Section VI, as modified by Decision No. 82-08-072 and Resolution No. T-10648, permits SMLECs to make GRC filings by advice letter or application.

Twelve SMLECs (see Appendix A) filed GRC advice letters on or before December 31, 1995. Five SMLECs (see Appendix B) filed GRC applications with the Commission's Docket Office instead.

Decision Nos. 96-05-026, 96-05-027, 96-05-028, 96-05-029, and 96-05-030, for the 5 SMLEC GRC applicants made rates subject to refund effective January 1, 1997, and adopted a procedural schedule as set forth in Appendix C. This schedule calls for a final Commission decision in the five general rate case applications by February 28, 1997.

DISCUSSION

Issues such as authorized rate of return, revenue estimates, expense estimates, and rate base components are common to the SMLEC filings in the advice letter and application filings. For consistency and uniformity purposes and efficient use of staff resources, it is desirable to have the 1997 test year rates for all SMLECs be approved by the Commission concurrently. Since the schedule for the 5 SMLEC GRC applications defers a final decision in those proceedings until February 28, 1997, Commission Resolutions for the 12 SMLEC GRC advice letters may not be approved until that date as well.

The 12 SMLEC advice letter filings involve both rate decreases and rate increases, effective January 1, 1997. Since final Commission action on these requests will not take place until after that date, it is imperative that the present rates remain in effect until after January 1, 1997, subject to refund/recovery at such time as the Commission does act on the GRC revenue requirement change requests. Accordingly, we will make the rates of the twelve SMLECs contained in Appendix A subject to refund/recovery effective January 1, 1997. The revenue requirement changes we authorize the twelve SMLECs in the future may be recovered by revised rates and/or a surcredit/surcharge on their respective customers.

FINDINGS

- 1. Decision No. 94-09-065 required all SMLECs to make GRC filings by December 31, 1995.
- 2. The twelve SMLECs listed in Appendix A filed GRC advice letters by December 31, 1995.
- 3. The five SMLECs listed in Appendix B filed GRC applications by December 31, 1995.
- 4. A final Decision on the GRC applications for the five SMLECs in Appendix B is not expected until February 28, 1997.
- 5. Commission Decision Nos. 96-05-026, 96-05-027, 96-05-028, 96-05-029, and 96-05-030 made rates for the five SMLECs who filed GRC applications subject to refund effective January 1, 1997.
- 6. The rates for the twelve SMLECs who filed GRC advice letters in Appendix A should be made subject to refund/recovery effective January 1, 1997.

THEREFORE, IT IS ORDERED that:

1. The present rates in effect for the twelve small local exchange telephone companies in Appendix A are made subject to refund/recovery effective January 1, 1997 pending final Commission action on their individual general rate case advice letter filings.

This Resolution is effective today.
