ROUTE REVISION DOCKET REQUEST TO CHANGE STOP AT SONOMA CITY HALL FROM SCHEDULED TO ON-CALL STATUS AND ADD TWO STOPS. Sonoma Airporter, Inc. (PSC-1146) is a passenger stage corporation authorized to transport passengers, their baggage, and express between points in Sonoma County, on the one hand, and San Francisco and San Francisco International Airport, on the other hand. Sonoma Airporter, Inc. has filed a request with the Commission pursuant to the Commission's Routé Revision Docket procedure for the revision of passenger stage operating routes. This request seeks to change the passenger pickup and discharge point at Sonoma City Hall from a scheduled stop to an on-call stop. The carrier finds that this change would permit a more efficient operation of its scheduled runs, since with the advent of oncall door-to-door service in the area, few passengers use the scheduled City Hall stop. Sonoma Airporter, Inc. also requests the addition of on-call stops at Washington Street and McDowell in Petaluma and at Atherton Road and U.S. Highway 101 in Novato. These stops would be used only as pick-up and discharge points to permit passengers of Sonoma Airporter, Inc. to transfer to other airport access carriers. Such transfer opportunities would enable Sonoma Airporter, Inc. to eliminate some loss-producing runs with few passengers while still offering full airport access service to the residents of Sonoma Valley. Notice of this request appeared in the Commission's Transportation Calendar on January 6, 1989. No protests were received. The Commission has considered the request and finds that the following is justified and is hereby granted: RRD NUMBER REQUESTED BY 207 Sonoma Airporter, Inc.

- 1. File written acceptance of the certificate revision granted by this resolution within thirty days of the date of the resolution.
- 2. File tariffs and timetables reflecting the route revision authorized by this resolution; allow at least ten days, notice to the Commission and to the public; establish service on the same day that tariffs and timetables become effective.
