RESOLUTION

RESOLUTION EXTENDING VOLUNTARY SUSPENSION OF PASSENGER  
STAGE CORPORATION CERTIFICATE OF PUBLIC CONVENIENCE  
AND NECESSITY HELD BY OLINTO LINDY BELLETTINI AND  
DOROTHY FRANCES BELLETTINI, DBA LINDY'S LIMO SERVICE,  
PSC-1393

Olinto Lindy Bellettini and Dorothy Frances Bellettini (Bellettini), doing business as Lindy's Limo Service, hold a certificate of public convenience and necessity as a passenger stage corporation (PSC-1393) for the transportation of passengers and their baggage between General Fox Airport, Edwards Air Force Base, and the Lancaster/Palmdale Service Area. The certificate was granted by Decision 85-05-085 in Application 84-10-066.

On January 7, 1988, Bellettini requested voluntary suspension of PSC-1393, citing illness as the reason for the request. Such voluntary suspension was granted by Resolution PE-2500, dated March 9, 1988. The period of voluntary suspension was scheduled to end one year from that date. Bellettini has since contacted the Commission staff and has requested that the period of voluntary suspension be extended until July 4, 1989; the additional time being needed to prepare for the resumption of service.

In these circumstances, the Commission finds that public convenience and necessity do not require the service of this carrier at this time.

IT IS ORDERED that:

1. The voluntary suspension of the certificate of public convenience and necessity as a passenger stage corporation of Olinto Lindy Bellettini and Dorothy Frances Bellettini (PSC-1393) granted by Resolution PE-2500 is hereby extended until July 4, 1989.

2. Prior to the resumption of service, tariff and timetable supplements cancelling the suspension supplements shall be filed. The required filing shall be made on not less than five days' notice to the public and to the Commission.
3. The authority to suspend operations granted herein shall expire on July 4, 1989 or upon earlier resumption of service, which may be accomplished through compliance with Ordering Paragraph 2 above.
4. Olinto Lindy Bellettini and Dorothy Frances Bellettini are placed on notice that commencement of operations under the certificate that is the subject of this resolution without complying with Ordering Paragraphs 2 and 3 may cause further suspension or revocation of their operating authority.
