RESOLUTION

RESOLUTION VOLUNTARILY SUSPENDING CERTIFICATE OF PUBLIC
CONVENIENCE AND NECESSITY ISSUED TO JOHN B. BERRISFORD
dba DESERT SHUTTLE (PSC 5870).

John B. Berrisford, dba Desert Shuttle was authorized by Decision (D.) 89-09-077 dated September 27, 1989 in Application (A.) 89-06-057 to operate as a passenger stage corporation. Authority provided service between certain points in the Counties of Riverside and San Bernardino, on the one hand, and the Los Angeles International Airport and the Ontario International Airport, on the other hand.

By letter dated October 16, 1990, John B. Berrisford, dba Desert Shuttle requested a voluntary suspension of PSC 5870 because of financial reasons. The period of voluntary suspension was scheduled to end one year from that date. Carrier indicated that he intends to resume operation on or before October 16, 1991.

IT IS ORDERED that:

1. The certificate of public convenience and necessity to operate as a passenger stage corporation of John B. Berrisford, dba Desert Shuttle (PSC 5870) granted by Decision (D.) 89-09-077 dated September 27, 1989, in Application (A) 89-06-057 is hereby suspended until October 16, 1991.

2. Prior to resumption of service, tariff and timetable supplements cancelling the suspension supplements shall be filed. The required filing shall be made on not less than five days notice to the public and to the Commission.
3. The authority to suspend operations granted herein shall expire on October 16, 1991 or upon earlier resumption of service, which may be accomplished through compliance with Ordering Paragraph 2 above.
4. John B. Berrisford, dba Desert Shuttle is placed on notice that commencement of operations under the certificate that is the subject of this resolution without complying with Ordering Paragraphs 2 and 3 may cause further suspension or revocation of their operating authority.

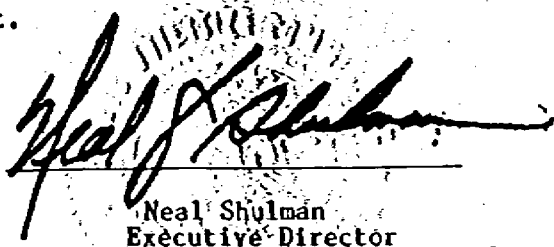
