R E S O L U T I O N

RESOLUTION VOLUNTARILY SUSPENDING CERTIFICATE PUBLIC
CONVENIENCE AND NECESSITY ISSUED TO HIGINIO C. ANG AND
MACRINA ANG, DBA RIDE-4-U (PSC 6009)

Higinio C. Ang and Macrina Ang, dba RIDE-4-U was authorized by Decision (D.) 90-06-041 dated June 20, 1990 in Application (A.) 89-08-037 to operate an on-call, door-to-door passenger stage service. Authority was granted to provide service between points in the Counties of Los Angeles and Orange on the one hand, and Los Angeles International Airport (LAX), Long Beach Airport (LGB), John Wayne Airport (SNA), or Los Angeles and Long Beach Harbors, on the other hand.

By letter dated April 5, 1991, Higinio Carlos Ang requested a voluntary suspension of PSC 6009 because of the moratorium placed by the Department of Airport in LAX. Carrier indicated that at the present time it will not be economically viable to operate their passenger stage authority until the moratorium will be lifted. The period of voluntary suspension was scheduled to end one year from that date. Carrier indicated that they intend to resume operation on or before April 5, 1992

IT IS ORDERED that:

1. The certificate of public convenience and necessity to operate as a passenger stage corporation between points in the Counties of Los Angeles and Orange on the one hand, and LAX, LGB, SNA, or Los Angeles and Long Beach Harbors, on the other hand, granted by Decision (D.) 90-06-041 dated June 20, 1990 in Application (A.) 89-08-037 is hereby suspended until April 5, 1992.
2. Prior to resumption of service, tariff and timetable supplements cancelling the suspension supplements shall be filed. The required filing shall be made on not less than five days notice to the public and to the Commission.

3. Comply with General Order 101-E by having on file evidence of insurance before you resume operation.
4. The authority to suspend operations granted herein shall expire on April 5, 1992, or upon earlier resumption of service, which may be accomplished through compliance with Ordering Paragraph 2 above.
5. Higinio C. Ang and Macrina Ang, dba RIDE-4-U is placed on notice that commencement of operations under the certificate that is the subject of this resolution without complying with Ordering Paragraphs 2, 3 and 4 may cause further suspension or revocation of their operating authority.


