## RESOLUTION VOLUNTARILY SUSPENDING CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY ISSUED TO ROBERTS HOLIDAY LINES INC., DBA RHL AIRPORTER (PSC-0165)

Roberts Holiday Lines, Inc., dba RHL Airporter was authorized by Decision (D.) 90-12-005 dated December 6, 1990 in Application (A.) 90-04-040 to operate as a passenger stage corporation. Authority was granted to provide service on schedule basis, betwen points in Orange County, on the one hand, to John Wayne Airport (SNA), on the other hand.

By letter dated April 22, 1991, Robert R. McKeehan, President on behalf of Roberts Holiday Lines Inc., dba RHL Airporter requested a voluntary suspension of PSC 0165 because of the moratorium placed by Orange County both in air and ground transportation. Carrier indicated that at the present time it will not be economically viable to operate their passenger stagé authority until the moratorium will be lifted. The period of voluntary suspension was scheduled to end one year from that date. Carrier indicated that they intend to resume operation on or before April 22, 1992

IT IS ORDERED that:

- 1. The certificate of public convenience and necessity to operate as a passenger stage corporation between points in Orange County, on the one hand, to SNA on the other hand, granted by (D.) 90-12-005 in (A.) 90-04-040 is hereby suspended until April 22, 1992.
- 2. Prior to resumption of service, tariff and timetable supplements cancelling the suspension supplements shall be filed. The required filing shall be made on not less than five days notice to the public and to the Commission.

- 3. Comply with General Order 101-E by having on file evidence of insurance before you resume operation.
- 4. The authority to suspend operations granted herein shall expire on April 22, 1992, or upon earlier resumption of service, which may be accomplished through compliance with Ordering Paragraph 2 above.
- 5. Roberts Holiday Lines, Inc., dba RHL Airporter is placed on notice that commencement of operations under the certificate that is the subject of this resolution without complying with Ordering Paragraphs 2, 3 and 4 may cause further suspension or revocation of their operating authority.
