RESOLUTION

RESOLUTION EXTENDING VOLUNTARY SUSPENSION OF CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY ISSUED TO DEL CORONADO TRAVEL AND PROPERTIES, INC. (PSC 5113).

---

Del Coronado Travel and Properties, Inc., a California corporation was authorized by Decision 88-12-016 dated December 9, 1988 in Application 88-08-029 to operate as a passenger stage corporation. The decision granted authority for service between Hotel del Coronado and San Diego International Airport (SAN) on an on-call basis.

On April 24, 1991 the Commission adopted Resolution TL-18418 which suspended until April 24, 1992 the certificate of public convenience and necessity to operate as a passenger stage corporation between Hotel Del Coronado and SAN on an on-call basis. By letter dated May 12, 1992, Martin Malk, President, Del Coronado Travel and Properties, Inc. requested to extend the voluntary suspension until May 12, 1993 because the operation is not feasible at the present time due to economic condition.

IT IS ORDERED that:

1. The certificate of public convenience and necessity to operate as a passenger stage corporation between Hotel Del Coronado and SAN on an on-call basis granted by Decision 88-12-016 dated December 9, 1988 in Application 88-08-029 is hereby suspended until May 12, 1993.

2. Prior to resumption of service, tariff and timetable supplements cancelling the suspension supplements shall be filed. The required filing shall be made on not less than five days notice to the public and to the Commission.
3. Comply with General Order 101-E by having on file evidence of insurance before you resume your operation.
4. The authority to suspend operations granted herein shall expire on May 12, 1993 or upon earlier resumption of service, which may be accomplished through compliance with Ordering Paragraph 2 above.
5. File quarterly report(s) of gross operating revenue and pay the required fees.
6. Del Coronado Travel and Properties, Inc. is placed on notice that commencement of operations under the certificate that is the subject of this resolution without complying with Ordering Paragraphs 2, 3 4 and 5 may cause further suspension or revocation of their operating authority.


