RESOLUTION

RESOLUTION VOLUNTARILY SUSPENDING CERTIFICATE OF PUBLIC  
CONVENIENCE AND NECESSITY ISSUED TO UNITED SHUTTLE  
SYSTEMS, INC. (PSC 1248).

---

United Shuttle Systems, Inc was authorized by Decision 82-09-072 dated September 22, 1982 in Application 82-05-36, to operate as a passenger stage corporation to transport passengers and their baggage between San Francisco International Airport (SFO), on the one hand, and points within the city limits of Modesto, Turlock, Lodi, Stockton, Manteca, Tracy, Merced, Atwater, Livermore, Pleasanton, and Dublin, on the other hand.

By letter dated May 21, 1992, Tim Schuppert, President requested to suspend passenger stage authority (PSC 1248) voluntarily because the insurance is too costly for the amount of revenue generated. The period of voluntary suspension will give the carrier an opportunity to sell their business. It was requested that the voluntary suspension end one year from that date. Carrier will be authorized to resume their operation on or before May 21, 1993

## IT IS ORDERED that:

1. The certificate of public convenience and necessity to operate as a passenger stage corporation between SFO, on the one hand, and points within the city limits of Modesto, Turlock, Lodi, Stockton, Manteca, Tracy, Merced, Atwater, Livermore, Pleasanton, and Dublin, on the other hand granted by Decision 82-09-072 dated September 22, 1982 in Application 82-05-36 is hereby suspended until May 21, 1993.
2. Prior to resumption of service, tariff and timetable supplements cancelling the suspension supplements shall be filed. The required filing shall be made not less than five days notice to the public and to the Commission.


3. Comply with General Order 101-E by having on file evidence of insurance before you resume operation.
4. The authority to suspend operations granted herein shall expire on May 21, 1993, or upon earlier resumption of service which may be accomplished through compliance with ordering paragraph 2 above.
5. File quarterly report(s) of gross operating revenue and pay the required fees.
6. United Shuttle Systems, Inc. is placed on notice that commencement of operations under the certificate that is the subject of this resolution without complying with Ordering Paragraphs 2, 3, 4 and 5 may cause further suspension or revocation of their operating authority.
