R E S O L U T I O N

RESOLUTION GRANTING GREGORY J. PHELPS, DBA MOUNTAIN EXPRESS, ROUTE REVISION DOCKET REQUEST TO ADD A STOP AT THE RALEY'S SHOPPING CENTER IN EL DORADO HILLS TO HIS ROUTE FROM POINTS IN EL DORADO COUNTY TO THE SACRAMENTO METROPOLITAN AIRPORT.

Gregory J. Phelps (Petitioner, PSC 7611) operates an airport shuttle service between Placerville, Cameron Park and the Sacramento Metropolitan Airport. Petitioner proposes to add a stop to serve El Dorado Hills which is along his route.

Notice of this request appeared in the Commission's Daily Transportation Calendar of July 15, 1991. No protests were received.

Since this requested service is urgently needed and there is no other public transportation available, petitioner may file tariffs, timetables, and establish service on the effective date of this resolution.


