RESOLUTION GRANTING VOLUNTARY SUSPENSION OF CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY ISSUED TO KENNETH CARPENTER, AN INDIVIDUAL DEA HOME TO MARKET SHUTTLE BUS SERVICE (PSC 8993).

Kenneth Carpenter, (carrier), an individual dba Ken's Home To Market Shuttle Bus Service (PSC 8993) was authorized by Decision 94-04-069 dated April 20, 1994 in Application 94-01-057 to transport passengers and their baggage between Hemet, East Hemet and San Jacinto in Riverside County.

By letter dated August 29, 1994, carrier requested voluntary suspension of his passenger stage authority because he does not have enough riders and it will not be economically feasible to operate at the present time. Carrier indicated that he intends to resume his operation at a later time.

IT IS ORDERED that:

 The certificate of public convenience and necessity to operate as a passenger stage corporation between Hemet, East Hemet and San Jacinto in Riverside County granted by Decision 94-04-069 dated April 20, 1994 in Application 94-01-057 is hereby suspended until August 29, 1995. olution TL-18679 Insportation Division Page 2 of 2

- 2. Prior to resumption of service, tariff and timetable supplements cancelling the suspension supplements shall be filed. The required filing shall be made on not less than five days' notice to the public and to the Commission.
- 3. The carrier shall comply with General Order 101-E by having on file evidence of insurance before resuming operations.
- 4. The authority to suspend operations granted herein shall expire on August 29, 1995 or upon earlier resumption of service, which may be accomplished through compliance with Ordering Paragraph 2 above.
- 5. The carrier shall file quarterly report(s) of gross operating revenue and pay the required fees during the suspension.
- Kenneth Carpenter, dba Ken's Hone To Market Shuttle Bus Service is placed on notice that commencement of operations under the certificate that is the subject of this resolution without complying with Ordering Paragraphs 2, 3, 4 and 5 may cause further suspension or revocation of his operating authority.
