
R E S O L U T I O N

RESOLUTION DENYING ISSUANCE OF CHARTER-PARTY CARRIER AUTHORITY
 AND HIGHWAY CARRIER AUTHORITY (INCLUDING AUTHORITY TO OPERATE AS
 A HOUSEHOLD GOODS CARRIER) FOR FAILURE TO SATISFY STATUTORY
 PROVISIONS OF THE PUBLIC UTILITIES CODE AND COMMISSION GENERAL

 fees.
5. Comply with highway safety requirements.
