APPROVING ISSUANCE OF CHARTER-PARTY CARRIER OF PASSENGER PERMITS TO PRIME TIME SHUTTLE INTERNATIONAL, INC. SUBCARRIERS PURSUANT TO SECTION 5384 (b) OF THE PUBLIC UTILITIES CODE

The applicants named in the attached schedule have applied for charter-party carrier permits under Section 5384(b) of the Public Utilities Code.
