RESOLUTION

RESOLUTION GRANTING VOLUNTARY SUSPENSION OF THE PASSENGER STAGE CORPORATION CERTIFICATE HELD BY CHUNG MING CHIU, DBA METRO AIRPORT SHUTTLE (PSC-10138)

Chung Ming Chiu (Applicant), dba Metro Airport Shuttle, holds a certificate of public convenience and necessity to operate as a passenger stage corporation (PSC-10138). The certificate authorizes Applicant to conduct on-call, door-to-door shuttle service between San Francisco and San Jose International Airports and various Bay Area points.

By letter dated June 5, 1999, Applicant requested voluntary suspension of his certificate for one year. He indicated that a moratorium on shuttle van services at San Francisco International Airport has created operational difficulties which will take him time to resolve.

The Rail Safety and Carriers Division recommends that Applicant's request be granted.

This is an uncontested matter in which the resolution grants the relief requested. Accordingly, pursuant to Pub. Util. Code Section 311(g)(2), the otherwise applicable 30-day period for public review is being waived.

THEREFORE, IT IS ORDERED that:

1. The passenger stage corporation certificate (PSC-10138) held by Chung Ming Chiu (Applicant), dba Metro Airport Shuttle, is suspended on the effective date of this resolution.
2. During the period of suspension Applicant shall file reports of gross operating revenue and pay the required fees pursuant to Pub. Util. Code Section 423.
3. Before resuming operations, Applicant shall make written request for reinstatement of his certificate to the Rail Safety and Carriers Division and comply with General Orders 101-B, 104, and 158-A.
4. Upon Applicant's compliance with Ordering Paragraph 3, the Executive Director is authorized to reinstate certificate PSC-10138.

5. The authority to suspend operations granted herein shall expire one year from the effective date of this resolution or upon earlier resumption of service, which may be accomplished through compliance with Ordering Paragraph 3.
6. Applicant is placed on notice that commencement of operations under the certificate without first complying with Ordering Paragraph 3 may cause further suspension or revocation of his operating authority.
