RESOLUTION

RESOLUTION AMENDING THE PASSENGER STAGE CORPORATION CERTIFICATE OF AIRPORTER, INC., DBA SANTA ROSA AIRPORTER (PSC 9023)

<u>SUMMARY</u>

This resolution grants the request of Airporter, Inc., dba Santa Rosa Airporter (Airporter), to amend its passenger stage corporation certificate to reflect a change in the type of service it provides at the Courtyard by Marriott and the Hilton Hotel in Santa Rosa from scheduled to reservation-only.

BACKGROUND

Airporter is a passenger stage corporation (PSC) authorized to transport passengers and their baggage between points in Mendocino, Sonoma and Marin Counties, on the one hand, and Oakland and San Francisco International Airports, on the other hand. Service generally is provided on a scheduled basis. However, certain designated stops are served only when a passenger has made an advance reservation.

Two of Airporter's authorized scheduled stops in Santa Rosa are the Courtyard by Marriott and the Hilton Hotel. As a result of changes in ownership or management at these hotels, Airporter has been informed that it may no longer serve the general public on these properties. Both hotels will permit Airporter to continue service limited to hotel guests on a reservation basis.

Notice of Airporter's request appeared on the Commission's Daily Calendar on September 1, 1999. A protest was received from Paul S. Silver, an attorney representing Sonoma County Airport Express, Inc. (Express). Express holds a PSC certificate and provides scheduled service in competition with Airporter between points in Sonoma County and San Francisco International Airport. Mr. Silver's objection is only to the change in service at the Courtyard by Marriott. The basis for the protest is that "such a change can only be accomplished by Commission action."

The Commission's Rail Safety and Carriers Division (Staff) does not object to Airporter's request. Staff offers that ideally a PSC stop should be available for use by the general public. However, it recognizes that a hotel for any number of reasons (liability and parking concerns among them) might not want the public on its property for the sole purpose of using an airport bus service. At the same time, the hotel may wish to have the service available for its guests. Staff points out that there are other stops in Santa Rosa at which Airporter provides scheduled service to the public.

DISCUSSION

We will grant Airporter's request. The carrier wishes to conform its PSC certificate to reflect service changes it must make for reasons that appear to be beyond its control. As Staff notes, it is desirable for PSC passenger stops to be available for use by the general public. We realize, however, that special circumstances may at times justify otherwise. We do not wish to force Airporter to totally abandon service at these two points when it has other scheduled stops in Santa Rosa, at which it serves the majority of its passengers. We would prefer to allow Airporter to determine whether it is operationally feasible to provide limited reservation-only service at the hotels without degrading its primary scheduled service. The fact that there is a competing carrier serving the area should be a strong inducement to Airporter to maintain a high level of service.

The filing by Paul S. Silver on behalf of Express does not give adequate reason to deny Airporter's request. Mr. Silver's protestation that only the Commission may act on the request suggests he was under the impression the matter was going to be handled through an informal staff process. By issuing this resolution, the Commission is in fact formally acting on Airporter's request.

We note that Airporter and Express are involved in matters currently before the Commission concerning the use of disputed stops in Santa Rosa.¹ Granting Airporter's instant request should not have an effect on those pending matters.

The Commission finds that Airporter's request is justified.

The draft resolution of the Rail Safety and Carriers Division in this matter was mailed to the parties in accordance with Pub. Util. Code § 311(g). No comments on the draft resolution were received.

- Airporter, Inc.'s request to amend its passenger stage corporation certificate (PSC 9023) to authorize reservation-only service at the Courtyard by Marriott and the Hilton Hotel, Santa Rosa, is granted.
- 2. Airporter, Inc. shall file amendments to its tariff and timetable reflecting the route revision authorized by this resolution; allow at least ten days' notice to the Commission; and establish service on the same day that tariffs and timetables become effective.
