Resolution TS-676 Application 85-10-010 Transportation Division

(RESOLUTION AUTHORIZING CON-WAY WESTERN EXPRESS, INC.) (TO CONTINUE IN EFFECT ITS ZIP CODE MILEAGE GUIDE 100)

Con-Way Western Express, Inc. (Con-Way) is authorized by Decision (D) 86-02-018 to use its Mileage Guide 100 for a test period of one year in lieu of the Commission's Distance Table 8 for the determination of freight charges for the transportation of property.

By letter dated January 15, 1987, Con-Way indicates that it is necessary to evaluate the effect of its zip code mileage guide on rate and revenue levels in connection with the Commission's reregulation program established by D. 86-04-045 and D. 86-12-102. Accordingly, Con-Way requests that the one year trial period which is scheduled to expire on February 28, 1987 be extended to July 1, 1987.

It is desirable that Con-Way's evaluation of its zip code mileage guide include the effects of recent changes made in the Commission's program for reregulation of transportation. Con-Way will be granted the required extension of time in order to file with the Commission a report which reflects current regulatory requirements. It is also necessary to allow sufficient time for our Transportation Division to review Con-Way's report and to make appropriate recommendations to the Commission. We will, therefore, authorize Con-Way to continue its Zip Code Mileage Guide 100 in effect until further order of the Commission.

Findings of Fact

- By D. 86-02-018 Con-Way was authorized to use its Zip Code Mileage Guide 100 in lieu of the Commission's Distance Table 8 for a one year period which will expire on February 28, 1987.
- The Commission modified its program for regulation of transportation of property by highway carriers by D. 86-04-045 and D. 86-12-102.
- 3. By letter dated January 15, 1987, Con-Way requests an extension of time to complete its evaluation of the effect of its Zip Code Mileage Guide 100 under our modified regulatory requirements.

4. The Commission's Transportation Division staff will need sufficient time to review Con-Way's report and to make appropriate recommendations to the Commission.

Conclusions of Law:

- 1. Con-Way's request for an extension of time for its 2ip Code Mileage Guide 100 to remain in effect should be granted.
- Con-Way should be required to submit a report to the Commission by July 1, 1987 on the effect of its Zip Code Mileage Guide 100 on its rate and revenue levels.
- 3. Con-Way should be authorized to continue in effect its Zip Code Mileage Guide 100 until further order of the Commission.

IT IS ORDERED that:

- 1. Con-Way Western Express, Inc. is authorized to continue in effect its Zip Code Mileage Guide 100 until further order of the Commission.
- 2. Con-Way Western Express, Inc., shall file with the Commission a report of the results of its Zip Code Mileage Guide 100 on its rates and revenue by July 1, 1987.

This resolution is effective today.
