RESOLUTION

CALIFORNIA-AMERICAN WATER COMPANY, MONTEREY DISTRICT (CAL-AM).
ORDER AUTHORIZING EXTENSION OF WATER SERVICE BEYOND THE
BOUNDARIES OF ITS PRESENT SERVICE AREA TO SERVE THE BRINK
PROPERTY (ONE SINGLE FAMILY DWELLING).

Cal-Am, by Advice Letter No. 296, filed April 11, 1986, requests authority to extend water service beyond the boundaries of its present area to serve a 10.5 acre parcel, described as Monterey County Parcel No. 187-111-03, located in Carmel Valley, Monterey County.

Decision (D.) 92793, dated March 17, 1981 in Case 9530 modified Ordering Paragraph No. 6 of D.89195 to read as follows:

"Cal-Am shall not extend water service beyond the boundaries of its present service area in the Monterey Peninsula District without prior Commission approval. A request for such approval shall be made by advice letter and shall include a copy of the approval of the Monterey Peninsula Water Management District pursuant to Water Code-Appendix, Section 118-386."

Section 118-386 requires owners or operators of water systems within the Monterey Peninsula Water Management District (MPWMD) to secure approval of the Board of Directors of MPWMD prior to the extension of their water systems. Dual jurisdiction over the extension of public utility water systems in the Monterey area has therefore been conferred by statute on MPWMD and on the Commission.

Mrs. Wally Brink, the owner of Monterey County Parcel No. 187-111-03, requested permission from MPWMD to obtain water service from Cal-Am for one single family dwelling. By letter dated January 8, 1986, MPWMD approved water service for the Brink property.

The Water Utilities Branch (Branch) has no objection to water service being provided to the Brink Property and recommends that Advice Letter No. 296 be approved.

The Commission's opinion, after investigation by the Branch, is that Cal-Am's filing is just, reasonable and in the public interest.

IT IS RESOLVED that:

- 1. Authority is granted to California-American Water Company, Monterey District, to extend its service to serve Mrs. Wally Brink's 10.5 acre parcel of land known as Monterey County Parcel No. 187-111-03, located in Carmel Valley, Monterey County. No more than one residential unit shall be served from this extension.
- 2. All other conditions of Decision Nos. 89195 and 92793 shall remain in effect.
- 3. This Resolution is effective today.
