## RESOLUTION

(RES. W-3714) RURAL WATER COMPANY (RWC). ORDER AUTHORIZING A GENERAL RATE INCREASE PRODUCING ADDITIONAL ANNUAL REVENUE OF \$21,968 OR 17.9% IN 1992.

BY DRAFT ADVICE LETTER ACCEPTED ON AUGUST 12, 1992.

SUMMARY

This Resolution grants an increase in gross annual revenue of \$21,968 or 17.9% for test year 1992. This increase will provide a 14.15% rate of return on rate base in test year 1992.

BACKGROUND

RWC, by draft advice letter accepted by the Water Utilities Branch (Branch) on August 12, 1992, requests authority under Section VI of General Order 96-A and Section 454 of the Public Utilities Code to increase rates for water service by \$45,835 or 37.4% in 1992. RWC's request shows 1992 gross revenue of \$122,700 at present rates increasing to \$168,535 at proposed rates to produce a 14.15% return on rate base. RWC presently serves 237 metered rate customers located in an area approximately three miles south of Oceana, San Luis Obispo County.

The present rates became effective on December 24, 1988, pursuant to Decision 88-10-029 which authorized a general rate increase of \$16,115 or 32.00%.

DISCUSSION

The Branch made an independent analysis of RWC's summary of earnings. Appendix A shows RWC's and the Branch's estimated summary of earnings at present, requested, and adopted rates for test year 1992. Appendix A also shows differences in operating revenues, operating expenses and rate base.

RWC was informed of the Branch's differing views of revenues, expenses, and rate base. RWC has stated that it accepts the Branch's estimates.

Enactment of Assembly Bill 2158 by the State Legislature requires the Department of Health Services (DHS) to adopt regulations establishing an annual billing procedure for the collection of funds from all public water systems in California to carry out the State's drinking water program. Since RWC will be required to pay its share of the DHS fee, the Branch recommends that RWC be allowed to file an advice letter rate increase request to offset the annual fee once it has been officially determined and the bill has been received.

RWC's draft advice letter requested rates which it estimated would produce a 14.15% rate of return on rate base. The summary of earnings in Appendix A also shows a 14.15% rate of return at the Branch's recommended rates. This rate of return is the mid-point of the 13.90% to 14.40% standard rate of return range recommended by the Branch for small 100% equity financed water utilities.

RWC's current rate structure is made up of three schedules: Schedule No. 1, General Metered Service; Schedule No. 2, Residential Flat Rate Service; and Schedule No. 5, Public Fire Hydrant Service.

Even though RWC does not have any flat rate service connections, the Branch recommends increasing both the service charge and the quantity charge by the system average percentage increase. This will continue the present rate design situation that if a flat rate customer using the system average of 23 Ccf per month were to change to metered rates, such customer would pay approximately the same amount.

Pursuant to Section 2713 of the Public Utilities Code, RWC is prohibited from charging any rates for service under Schedule No. 5, Public Fire Hydrant Service, without a formal agreement with a local fire protection agency. Because RWC has no such agreement, the Branch recommends that Schedule No. 5 should be cancelled.

RWC's filed tariffs do not contain the recent revisions to its preliminary statement. RWC should be ordered to file the most recent revisions to this tariff sheet when it files its revised rate schedules.

RWC's source of water supply, the Santa Maria Basin and Nipomo Sub-Basin aquifer, has not been significantly affected by California's current drought. For this reason, the Branch believes that no further conservation measures should be ordered at this time.

At the Branch's recommended rates shown in Appendix B, the bill for a typical flat rate residential customer with a 5/8-inch service would increase from \$39.06 per month to \$45.18 or an increase of 15.7%, per month. A comparison of customer bills at present and Branch recommended rates is shown in Appendix C.

#### NOTICE AND PROTESTS

A notice of the proposed rate increase was mailed to each customer on August 19, 1992. The Branch received phone calls and letters representing approximately twenty percent of the ratepayers (45 connections) regarding the proposed rate increase. The protestants' letters stated the increase was too large; there were no complaints regarding service.

On October 5, 1992, a public meeting was held in the RWC's service area for all ratepayers. The owner, and his accountant, explained why the company was requesting the increase to the 31 ratepayers present at the meeting that was

facilitated by Senior Utilities Engineer, Art Mangold. The owner, Mr. Baker, explained that fixed costs have increased and in order to receive a reasonable return on the rate base an increase was required. At this meeting, they also complained about: (1) need for a more responsive emergency service, (2) the water requires an elaborate water softening treatment to be palatable, and (3) the latest hydrants installed have not been tested, have no pressure, or leak. Overall the ratepayer comments were based on amount of the rate increase and not on the quality of the water or of RWC's service. RWC's owner assured the customers that he would take care of all service-related problems. As far as water quality is concerned, it meets State Department of Health Services's potable water standards. The installation of treatment plant to soften water would be very expensive. The Commission's Consumer Affairs Branch has received 11 complaints against RWC over the last four years that were resolved over the phone.

#### FINDINGS AND CONCLUSIONS

1. The Branch's recommended summary of earnings (Appendix A) is reasonable and should be adopted.
2. The rates recommended by the Branch (Appendix B) are reasonable and should be adopted.
3. The quantities (Appendix D) used to develop the Branch's recommendations are reasonable and should be adopted.
4. RWC's filed tariffs do not contain the recent revisions to its preliminary statement. RWC should be ordered to file the most recent revisions to this tariff when it files its revised rate schedules.
5. RWC's tariff Schedule No. 5, Public Fire Hydrant Service is no longer applicable and should be canceled.
6. The rate increase authorized herein is justified, and the resulting rate is just and reasonable.

#### IT IS ORDERED that:


1. Authority is granted under Public Utilities Code Section 454 for Rural Water Company to file an advice letter incorporating the summary of earnings and revised rate schedule attached to this resolution as Appendices A and B respectively, and concurrently to cancel its presently effective rate Schedule Nos. 1, 2, and 5. It shall also file the recent revisions to its preliminary statement. Its filing shall comply with General Order 96-A. The effective date of the revised rate schedules shall be five days after the date of filing.
