Subject: R.07-05-025, DA OIR, Detailed proposal for addressing Local RA obligations in the context of the DA reopening

Parties -- During the discussion that followed the January 11, 2010 workshop in this proceeding, several parties approached me to discuss in further detail TURN's suggestion that a temporary fix be developed to address the issue of Local RA obligations when the DA market reopens in April of this year. Conversations have continued since that time, so I am circulating the attached proposal that puts "the meat on the bones" of the proposal discussed in TURN's written comments and verbally at the workshop. While this proposal is currently TURN's alone, I welcome the suggestions and, potentially, support of other parties.
