As reflected in the attached agenda, the Association of California Water Agencies' (ACWA) Energy Committee/Climate Change Subcommittee and the Commission's Policy & Planning Division will co-host a joint meeting at the CPUC on Monday, March 29th from 9:30-4:00. The meeting will be a joint informational meeting between ACWA's Energy Committee (ACWA Climate Change Subcommittee) and representatives from the

Energy IOU's (PG&E, SCE, SDG&E).

ACWA is interested in convening this joint meeting between its Energy Committee and representatives from the Energy IOU's in order to gain a better understanding of new opportunities for partnerships between the energy and water utilities in developing renewable energy and promoting energy efficiency.
