All of the following data requests address questions related to PG&E's Application 09-02-019 (SPVP), but pertain specifically to Page 3 of the document entitled "PG&E's 500 MW Solar Photovoltaic Program" that was the attachment to Notice of Ex Parte Communication filed on February 12, 2010 that reported the ex parte meeting between PG&E representatives and Andrew Schwartz, Advisor to Commission President Peevey that occur on February 9, 2010.

The above referenced "Page 3" is entitled "PD Ratemaking Proposal – Illustrative" and appears to represents a graph of information. All questions below pertain specifically to information presented on that page. Therefore, any reference to "page" refers to page 3 of the above referenced attachment of the February 12, 2010 Notice of Ex Parte Communication.

Please answer the following questions or data requests:

- 1. Define "COS", "PPA-1", and "PPA-2" that are printed in the upper right hand corner of the page.
- 2. What is the range of Y-axis of the graph?
- 3. What does the "\$" represents on the Y-axis?
- 4. Provide all data that was used to construct the three lines entitled "COS", "PPA-1", and "PPA-2."
- 5. Provide the explanation for how the data was selected to construct the three lines entitled "COS", "PPA-1", and "PPA-2, including the slopes of each line.
- 6. Provide all supporting information to justify the points of intersections between the three lines entitled "COS", "PPA-1", and "PPA-2. For instance, lines COS and PPA-1 appear to cross at about year 6.5 and line COS and line PPA-2 appear to intersect at about year 24.5.
