Pursuant to Rule 8.3(a) of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) hereby gives notice of the following *ex parte* communication. The communication occurred on Wednesday, March 10, 2010, at approximately 3:00 p.m. by telephone to the offices of the California Public Utilities Commission in San Francisco. The communication was oral. [Rule 8.3(a)(1)]

Sidney Dietz, Director, Regulatory Relations, PG&E, initiated the communication with Jamie Fordyce, Advisor to Commissioner Dian Grueneich. [Rule 8.3(a)(2)]

Mr. Dietz stated that PG&E supports the Energy Curtailment Specialists, Inc. (ECS) contract expansion because it brings clean, cost-effective peak MW supplied by Demand Response (DR) to PG&E customers consistent with the Loading Order. Mr. Dietz further stated that when the ECS contract was filed on February 28, 2007, it complied with the contemporary DR rules, which were only subsequently changed. Mr. Dietz stated that the proposed decision should be changed to approve the ECS contract

expansion. [Rule 8.3(a)(3)].
