All,

Sorry I didn't get back to you all sooner.

This is how we are going to handle the due date for the Q42009 Report (excel, E3, narratives) and Q42009Tracking Data in SPT DB format.

PGE and SCE can submit both the Q42009 report AND the Q42009 Tracking Data in SPT DB format by next week 3/26/10.

Sempra can submit both the Q42009 report AND the Q42009 Tracking Data in SPT DB format by 5/1/2010.

This actually works out well because PGE and SCE are the largest data sets and I will need more time to review the Q42009 Tracking Database to make sure the data were populated correctly.

Note - I know Darren sent an email about the 2009 avoided cost and this entire group still has to meet to discuss 2010-2012 reporting. This email only addressed the Q42009 report and Q42009 Tracking Data in SPT db.
